**The yeas and nays having been completed at nineteen minutes past three o'clock P.M., the bill was passed to be enacted, two-thirds of the members present having agreed to pass the same.**

**Subsequently, Mr. Pacheco moved that the Senate reconsider the vote by which the Senate had passed the bill to be enacted.**

**Under the provisions of Senate Rule 53, the question on reconsideration was placed first in the Orders of the Day for the next session.**

*Engrossed Bill Returned with Recommendation of Amendment.*

A Message from His Excellency the Governor, returning with recommendation of amendment the engrossed Bill further regulating employer contributions to health care (see House, No. 3822) (its title having been changed by the Senate committee on Bills in the Third Reading) [being the text contained in Sections 16, 17, 60 to 67, inclusive, 93, 110, 122, 146, 147 and 150 of the General Appropriations Bill (see House, No. 3650) [for message, see Attachment D of House, No. 3800],— came from the House with the endorsement that the House

had *rejected* the amendment recommended by the Governor, and had adopted the following amendment by inserting after section 10 the following two sections:-

“SECTION 10A. Chapter 47 of the acts of 2017 is hereby amended by inserting after section 149 the following section:-

Section 149A. Section 54 shall take effect on September 30, 2022.

Section 10B. Said chapter 47 in hereby further amended by striking out section 1515.”; and by striking out section 17 and inserting in place thereof the following section:

“SECTION 17. Section 14 shall take effect on January 1, 2020.”

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was before the Senate subject to amendment and re-enactment.

The rules were suspended, on motion of Ms. Spilka.

The same Senator moved that the Senate *reject* the Governor’s amendment and that the House amendment be adopted.

After debate, the question on rejection of the Governor’s recommendation of amendment was determined by a call of the yeas and nays, at fourteen minutes past four o’clock P.M., as follows, to wit (yeas 32 — nays 6) [**Yeas and Nays No. 68**]:

**The yeas and nays having been completed at twenty minutes past four o’clock P.M., the Governor’s amendment was *rejected*.**

**The House amendment was then considered; and it was adopted, in concurrence.**

**Sent to the House for re-enactment.**

A Bill relative to simulcasting and racing (House, No. 208, amended,-- on petition),-- was read.

Simulcasting.

**There being no objection, the rules were suspended, on motion of Mr. Boncore, and the bill was read a second time and, after remarks, was ordered to a third reading, read a third time and passed to be engrossed, in concurrence.**

*Emergency Preambles Adopted.*

An engrossed Bill relative to simulcasting and racing (see House, No. 208, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Simulcasting.

**The bill was signed by the President and sent to the House for enactment.**

An engrossed Bill further regulating employer contributions to health care (see House, No. 3822, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 5 to 0.

Health care.

**The bill was signed by the President and sent to the House for enactment.**
