Monday, April 1, 2019.

Met at four minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair)

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

There being no objection, the Chair (Mr. Brownsberger) handed the gavel to Mr. Tarr for the purpose of an introduction. Mr. Tarr then introduced, in the rear of the Chamber, the Masconomet Regional High School Gymnastics, MVG- 2018-2019 State Champions. Among the group were: Team Captains Nicole Bonacorso, Catherine DiNanno, Dannielle Tremblay, and team members Katelyn Aylwin, Sarah Aylwin, Lena Boldi, Alexa Budrow, Maria Buhaescu, Payton Coleman, Katerina Cote, Kyra Flak, Keira Fowler, Amber Gamache, Makayla Greene, Joanna Londi, Charlotte Losee, Gracy Mowers, Julianna Pascuccio, Emma Quirk, Lanah Rosenwald, Jessica Serafino, Samantha Tremblay, Gabrielle Wayland, and Paige Zimmerman. The Masconomet Gymnastics team went undefeated (8-0) in the regular season and went on to win the NEC/CAL league, North Section of the State Competition, and ultimately the State Championship for the first time in the school's history. Gymnast Katelyn Aylwin, who qualified to the national competition, will represent Massachusetts this May in Florida. The team was accompanied by Head Coach Alicia Gomes and Team Manager Mariah Wheeler. The Senate applauded their accomplishments and they withdrew from the Chamber. They were also guests of Senator Lovely and Representatives Hill of Ipswich, Mirra of West Newbury and Speliotis of Danvers.
