Thursday, April 18, 2019.

Met at eleven minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

## Adjournment in Memory of Reverend Eugene Loring Alves.

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it do so in memory of Reverend Eugene Loring Alves, who passed peacefully at the age of 87 on February 8, 2019, surrounded by his loving family.

Father Gene was a graduate of Gloucester High Class of 1949, where he was a recipient of the Sawyer Medal and held the rank of 1st Lieutenant in the ROTC. He

received his Bachelor's degree in 1953 and graduated cum laude from The College of the Holy Cross. In 1954, he received his Master of Arts degree from Boston College Graduate School. After a 2-year term of service in the U.S. Army, he entered St. John's Seminary in 1956 and was ordained to the priesthood on February 2, 1961.

Father Gene began his pastoral journey with assignments to St. Anthony's Parish in Woburn and St. Francis of Assisi Parish in Medford. In 1965, he became a Newman Chaplain serving U-Mass Boston and Suffolk University and Chaplain to the Catholic Alumni Club of Greater Boston.

In 1974 at 42 years of age, he was appointed Administrator of Our Lady of Good Voyage Church. He grew up within a stone's throw from the church in Gloucester. The move proved to be the perfect fit for him and for the people of Our Lady's as he led the church onward, carrying out the traditions and customs unique to Gloucester, particularly those of the Portuguese Community. He retired in 2014 with 40 years of service, and assisted at Our Lady's in spiritual duties until his decline in health over this past year. He celebrated his 58th anniversary in the priesthood on February 2nd.

Father Gene is survived by his sister Blanche L. Alves, nephews Mark and Kenneth Davis, and his niece Anita McCarthy, as well as various great-nephews and great-nieces.
