*Ordered*, That, the Senate hereby calls for a joint session of the two Houses, conformable to the provisions of Article XLVIII (as amended by Article LXXXI) of the Amendments to the Constitution, to consider the following proposal:

Proposal for a legislative amendment to the Constitution to provide resources for education and transportation through an additional tax on incomes in excess of one million dollars (see Senate, No. 16), with reference to which the committee on Revenue has reported, recommending that the amendment ought to pass.

**There being no objection, the rules were suspended, on motion of Mr. Humason and the order was considered forthwith and adopted.**

Mr. Eldridge offered the following order, to wit:

*Ordered*, That, the Senate hereby calls for a joint session of the two Houses, conformable to the provisions of Article XLVIII (as amended by Article LXXXI) of the Amendments to the Constitution, to consider the following proposal:

Proposal for a legislative amendment to the Constitution establishing an independent redistricting commission (see Senate, No. 13), with reference to which the committee on Election Laws has reported, in accordance with Joint Rule 23, that the amendment ought NOT to pass.

Proposal for a legislative amendment to the Constitution requiring a supermajority vote for the utilization of rainy day funds (see Senate, No. 2210), with reference to which the committee on Revenue has reported, in accordance with Joint Rule 23, that the amendment ought NOT to pass, the time within which the said committee was required to report having expired.
