Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for David P. Christian, an employee of the Department of Correction (see Senate, No. 1541, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President and sent to the House for enactment.

Mark B. Lyons passed away on Tuesday, August 6, 2019 at the age of 67. Beloved husband and best friend of Althea Lyons; loving father of Alex and his wife Madison; daughter Julia and her partner Kristian Hval; son of the late Ethel and Irving Lyons; and cherished son-in-law of Ileana Koles.

Mark Lyons was born and raised in Malden, Massachusetts. He practiced law for over 35 years and was the founding partner of Lyons & Tzanoudakis, LLP, in Danvers. Mark B. Lyons was the Chairman of the Board Selectman in Topsfield. He served as Chair for the Topsfield Finance Committee, Chair of the Topsfield Elementary School Committee, and as a Member of the Topsfield Planning Board. He was also a member of the Topsfield Town Hall Committee. Mark was an avid New England Sports fan, enjoyed visiting Cape Cod, and spending time with family and friends.
