JOURNAL OF THE SENATE

Monday, September 16, 2019.

Met at six minutes past eleven o'clock A.M. (Mr. Rodrigues in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Rodrigues), members, guests and staff then recited the pledge of allegiance to the flag.

UNCORRECTED PROOF.

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The Senate Bill concerning health insurance benefits for surviving spouses of firefighters in the city of Boston (Senate, No. 1483),-- was read a third time and passed to be engrossed.

Sent to the House for concurrence.

Report of a Committee.

By Mr. Rodrigues, for the committee on Ways and Means, that the Senate Bill to protect children, families, and firefighters from harmful flame retardants (Senate, No. 1230),-- ought to pass with an amendment substituting a new draft with the same title (Senate, No. 2338).

Order Adopted.

Mr. Rodrigues offered the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the Senate Bill to protect children, families, and firefighters from harmful flame retardants (Senate, No. 1230) (the committee on Ways and Means having recommended that the bill be amended by substituting a new draft, Senate, No. 2338) shall be placed in the Orders of the Day for a second reading on Thursday, September 19, 2019.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 12:00 noon, on Wednesday, September 18, 2019. All such amendments shall be second reading amendments to the Senate Ways and Means new draft (Senate, No. 2338), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

Subsequently, Ms. Lovely, for the said committee, reported, recommending that the order ought to be adopted.

The rules were suspended, on motion of Mr. deMacedo, and the order was considered forthwith and adopted.

PAPER FROM THE HOUSE.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Kiera C. McNamara, an employee of the Trial Court of the Commonwealth (see House, No. 3970, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Rodrigues) and sent to the

Matter Taken Out of the Orders of the Day.

There being no objection, the following matter was taken out of the Orders of the Day and considered as follows:

The House Bill establishing a sick leave bank for Ryane Linehan, an employee of the Department of Revenue (House, No. 4056),-- was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Tarr presented an amendment inserting after the second sentence the following sentence:- "Upon exhaustion of all other available leave time, including personal days, vacation days, sick time and any time available pursuant to the extended illness leave bank established by section 4P of chapter 7 of the General Laws, Ryane Linehan shall be permitted to use any time credited to the sick leave bank established by this act."

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence with the amendment.

Engrossed Bill.

An engrossed Bill establishing a sick leave bank for Kiera C. McNamara, an employee of the Trial Court of the Commonwealth (see House, No. 3970, amended) (which originated in the House) having been certified by the Senate Clerk to be rightly and truly prepared for final passage was passed to be enacted, two-thirds of the members present having voted in the affirmative, and signed by the Acting President (Mr. Timilty) and laid before the Governor for his approbation.
