Met at four minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

The Senate Bill further regulating the sale and consumption of alcoholic beverages at certain polling places in the town of Middleton (Senate, No. 2344),-- came from the House passed to be engrossed, in concurrence *with an amendment* striking out all after the enacting clause and inserting in place thereof the following:

Middleton.-- polling

“SECTION 1. Notwithstanding section 24 of chapter 54 of the General Laws, the town of Middleton may designate polling places in any building or location; provided, that alcoholic beverages shall not be served or consumed in that portion of a building or location used as a polling place, during voting hours or while ballots are being counted therein.

SECTION 2. This act shall take effect upon its passage.”

**The rules were suspended, on motion of Mr. Fattman, and the House amendment was considered forthwith and adopted, in concurrence.**

The Senator from Worcester and Norfolk, Mr. Fattman, moved that when the Senate adjourns today, it do so in memory of Daniel J. Hollis, 19, of Mendon who passed away Wednesday, October 2nd, 2019, in Brigham and Women's Hospital, Boston with is family by his side from injuries sustained from an assault in Boston.

Daniel was many things student, athlete, leader, artist, music-lover, and friend. He was just 19 years old and only beginning to experience the world around him. His family and the small town of Hopedale, Massachusetts provided a strong foundation from which he took off to explore the thrills of life in the city at Emerson College. He looked forward to traveling abroad and expanding his creative pursuits through clothing design and marketing. While often receiving recognition for his play on the field or ice, it was the camaraderie of the team that Dan most loved about sports. For Daniel, life was about relationships and enjoying experiences with others.

A 2018 graduate of Hopedale Jr. & Sr. High School, he served as class secretary for six years. He was a member and former Captain of the Hopedale Lacrosse Team where he is recognized as one of the State's all-time leading lacrosse goalies. He also played and was the Asst. Captain with the Hopedale-Milford Co-Op High School Hockey team, a member of the Hopedale High School Golf Team, and played for a number of youth hockey organizations and club lacrosse teams. At Emerson College, he was presently a member of the Emerson College Lacrosse Team.

Dan is survived by his parents Jason R. Hollis and Jennifer A. Kelly; his sister

Kathryn L. Hollis; his paternal grandparents Richard and Maryan Hollis; many aunts, uncles, and cousins, and his trusted canine companion Bauer. He was predeceased by his maternal grandparents, Janet and Norbert Kelly, Jr.

The Senator from Suffolk, Mr. Collins, moved that when the Senate adjourns today, it adjourn in memory of William E. McGonagle.

William E. McGonagle, of South Boston, passed away Wednesday, October 9th, surrounded by loving family. Beloved husband of forty-seven years to Ellen M. (Regan) McGonagle. Devoted father of Matthew R., his wife Laura A. of Hull, Mark R., his wife Kathlin of Dorchester, Alyson R. Perschke and her husband Eric of Dorchester. Loving "Papa" of Maggie, Andrew, Lucy, Evelyn, Calvin, Dylan and Bella. Loving son of Daniel and Jeannette (Geary) McGonagle. Dear brother of Anne Connolly, Daniel "Mickey" McGonagle, Edward, Mary Jane "Mamie" Berger and Elenanor "Ellie" Bosse. Also survived by many loving nieces, nephews, relatives and friends.

Billy was a longtime Administrator of the Boston Housing Authority and Late Veteran US Navy, RES. Mr. McGonagle was a lifelong resident of South Boston and was a product of public housing himself, having grown up in the Mary Ellen McCormack, the State's oldest public housing development. Through his hard work and dedication at the BHA he rose through its ranks from janitor to executive assistant before being named administrator of the BHA in 2009, and he served in that role under two mayoral administrations.

As Administrator, he provided housing for over 50,000 residents, with 25,000 residents housed directly through the BHA and 25,000 residents housed through vouchers administered by Authority, and has worked tirelessly on behalf of these residents. During his tenure he helped moved Boston become a more inclusive and accepting city by removing barriers to public housing to ensure that residents in every neighborhood had access to quality housing. He championed and supported public housing and it residents throughout his career, and has been recognized by the urban league of Eastern Massachusetts, the Mass Union of Public Housing Tenants, and the South Boston Citizen's Association for his tireless efforts in uplifting Boston's most vulnerable residents.
