There being no objection, the rules were suspended, on motion of Mr. Fattman, and the bill was read a second time and ordered to a third reading.

A Bill establishing a sick leave bank for Susan St. Laurent, an employee of the Trial Court of the Commonwealth (House, No. 4156,-- on petition),-- was read.

There being no objection, the rules were suspended, on motion of Mr. Montigny, and the bill was read a second time and ordered to a third reading.

The Orders of the Day were considered as follows:

Bills

Accepting certain property in Gloucester for park and conservation purposes under Article 97 of the Massachusetts Constitution (Senate, No. 2330);

Relative to the health insurance and other benefits in the town of East Brookfield (House, No. 2167);

Relative to the capital expenditures committee of the town of Lexington (House, No. 4035); and

Authorizing the town of Gill to continue the employment of Gene M. Beaubien (House, No. 4055);

Were severally read a second time and ordered to a third reading.

The House Bill to support improving financial stability in higher education (House, No. 4099, amended),-- was read a second time.

After remarks and pending the question on adoption of the amendment, previously recommended by the committee on Ways and Means, striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2387, and pending the main question on ordering the bill to a third reading, Messrs. Moore, Tarr and Montigny moved that the proposed new text be amended by inserting after section _____ the following section:-

. There shall be a special commission on tuition and fee-free and "SECTION debt-free public higher education to consist of: the commissioner of higher education, or a designee, who shall serve as chair; the president of the University of Massachusetts system or a designee; a representative selected by the council of presidents of the state university system; a representative selected by the Massachusetts Association of Community Colleges; the senate and house chairs of the Joint Committee on Higher Education or their designees; and 5 persons to be appointed by the commissioner of the department of higher education, 1 of whom shall be selected from a list of 3 nominees submitted by the Massachusetts Teachers Association, 1 of whom shall be selected from a list of 3 nominees submitted by the Massachusetts Budget and Policy Center, 1 of whom shall be selected from a list of 3 nominees submitted by the Public Higher Education Network of Massachusetts; 1 of whom shall be from the American Student Assistance and 1 of whom shall be a student representative currently enrolled in a public higher education institution in the commonwealth. The commission shall examine and make recommendations on the creation of tuition and fee-free and debt-free college programs in the Commonwealth including, but not limited to: (i) student eligibility including possible requirements for state residency, maximum family income, academic thresholds/GPA, and enrollment status (full-time or part-time); (ii) which public institutions would be eligible, enrollment shifts that may occur, and the potential effect on academic program quality; (iii) the cost to fund the various models explored, including the ordering of state and federal aid required to be applied as 'first dollar' or 'last dollar' and the cost of covering indirect costs such as books, housing, transportation or other significant matriculation costs; (iv) the potential impact of debt-free college on student debt and degree completion; and (iv) review of currently offered debt-free proposals in other states. The first meeting of the commission shall take place within 45 days after the effective date of this section. The commission shall file a report detailing its recommendations with the clerks of the senate and house of representatives on or before May 31, 2020."

The amendment was rejected.

Mr. Tarr moved that the proposed new text be amended by inserting in line 25 after the word "public" the following:- "shall also submit the financial report to the clerks of the house and senate, and the joint committee on higher education".

The amendment was rejected.

Mr. Welch moved that the proposed new text be amended in section 1, in line 13, by inserting after the word "trustees", the following: "finance committees or related bodies, who do not have a financial background or MBA, CPA or like degree,";

In section 2 by inserting, in line 83, after the word "body", the following: "[body]'s finance committee or related body, who do not have a financial background or MBA, CPA or like degree,"; and

In section 3 by inserting, in line 92, after the word "member" the following: "of the finance committee or related body, who do not have a financial background or MBA, CPA or like degree,".

After remarks, the amendment was rejected.

Mr. Welch moved that the proposed new text be amended in section 2 by inserting in line 87 after the word "statement," the following, "only if the board and accrediting agency jointly identify a risk of imminent closure,".

The amendment was rejected.

Ms. DiZoglio and Mr. Finegold moved that the proposed new text be amended in line 52, by inserting after the word "education" the following words:- "provided that, in conducting any financial screenings, the department shall evaluate an institution using financial standards that are similar to those used by an accrediting agency".

After remarks, the amendment was rejected.

Mr. Tarr moved that the proposed new text be amended by inserting after section _ the following section:-

"SECTION_. Section 8F of chapter 12 of the mass general laws as appearing in 2018 official edition is hereby amended by inserting in line 4 after the word 'year' the following:- "provided that such time for submission shall not be later than 5 months of preceding fiscal year."

The amendment was rejected.

Mr. Rodrigues moved that the proposed new text be amended in section 2, in proposed paragraph (3) of section 31B of chapter 69, by striking out the first sentence and inserting in place thereof the following sentence:- "Upon either: (i) a determination by the board that an institution may be at risk of imminent closure; or (ii) acceptance by the board of a determination made by an accrediting agency that an institution may be at risk of imminent closure, the board shall provide the institution with a summary of the basis for its determination."

The amendment was adopted.

The Ways and Means amendment, as amended, was then adopted.

The bill, as amended, was then ordered to a third reading and read a third time.
