Thursday, October 31, 2019.

Met at ten minutes past eleven o'clock A.M. (Mr. Lewis in the Chair) (having been appointed by the President, under authority conferred under Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Lewis), members, guest and staff then recited the pledge of allegiance to the flag.

Engrossed Bills.

The following engrossed bills (both of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Lewis) and laid before the Governor for his approbation, to wit:

Authorizing the city of Everett to provide certain death, retirement and medical benefits to the widow and children of deceased firefighter Thaddeus M Baxter, Jr. (see Senate, No. 2332).

All such amendments shall be second-reading amendments to the Senate Ways and Means new text (Senate, No. 2391), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

Subsequently, Ms. Lovely, for the said committee, reported, recommending that the order ought to be adopted.

The rules were suspended, on motion of Mr. deMacedo, and the order was considered forthwith and adopted.

The bill will be placed in the Orders of the Day for Thursday, November 7, 2019, for a second reading with the amendment pending.

Adjournment in Memory of James "Jim" Roberts.

The Senator from First Hampden and Hampshire, Mr. Lesser, moved that when the Senate adjourns today, it adjourn in memory of James "Jim" Roberts of Ludlow.

On Wednesday, October 2, James was among seven passengers who died when a World War II B-17 Flying Fortress crash-landed at Bradley International Airport in Windsor Locks, Connecticut. Because of his enthusiasm for military history, Jim was excited for the chance to fly on such a plane.

Deeply rooted in Western Massachusetts, Jim was born in Springfield on December 8, 1970 as the youngest son of the late Joseph and Margaret Roberts. Following his high school graduation in 1988 from Minnechaug High School in Wilbraham, he obtained his associates degree from Springfield Technical Community College. With this degree, Jim went on to work as a production supervisor at H.P. Hood for many years.

When he was not at work, Jim lived a life full of adventure. He was a talented artist with a dream of one day publishing his own comics. He had a passion for military history, and enjoyed gaming, skiing, and snowboarding. Whenever he got the opportunity, Jim loved cheering on his favorite New England teams-- the Red Sox and Patriots. Jim loved spending time with family and friends, was hard working, and deeply cared about those around him.

He is survived by his siblings Joseph, Greg, Michael, Sharon, and his beloved nieces
