## JOURNAL OF THE SENATE

Thursday, December 5, 2019.

Emergency Preamble Adopted.

## Adjournment in Memory of Maureen Burgess.

The Senator from the Cape and Islands, Mr. Cyr requests that when the Senate adjourns today, it adjourn in memory of Maureen Burgess, of Truro, who died on November 11, 2019. She was 72 years old.

An avid learner, Maureen graduated from New York University at the age of 21 with a license in physical therapy. She continued on to receive a master's degree in developmental psychology from Columbia University. In all of her studies and later work she focused on improving the lives of children. Maureen ran a pediatric physical therapy practice until 1998 when she became a faculty member at New York Medical College.

In 2003 Maureen and her husband retired to Truro. Since 2012 she represented Truro on the Cape Cod National Seashore Advisory Commission. She advised Seashore managers on responsible management of the national park lands that span the outer cape. A staunch environmentalist, she fought hard for years for the safe closure of Pilgrim Nuclear Power Plant. In 2014, Maureen was elected to the Truro Select Board. She was known as a dedicated, persistent, and engaged public servant. She always did her homework and was a full participant in everything she did as a member of the board. She truly wanted the best for Truro, listened to the townspeople, and was a voice for collaboration and consensus building. She also volunteered with the International Fund for Animal Welfare to protect nesting birds.

Maureen is survived by her husband of 48 years, peter, along with cousins, nieces, and nephews. She will be sorely missed by her friends and neighbors in Truro, but all are grateful for her warmth and service.
