Monday, January 27, 2020.

Food was not just a part of his professional life, but also a personal passion that he loved to perfect.

Mik had a passion for music that he shared with many as lead singer for the bands Zoid and GRIDLOCK. His most memorable recent performance was in 2018, when he was able to perform with his friend Ritchie Moore at Bridget's wedding to Ryan O'Rourke.

Mik was also a huge sports fan. The New York Yankees were a big part of his life and he loved attending games with friends and family whenever possible. He also loved NASCAR as he frequented races in the Pocono's with friends and family.

Through his work, Mik touched the lives of many serving as an important example for others to follow and to live by.
