Met at six minutes past eleven o'clock A.M. (Mr. Rush in the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

Reports of Committees.

By Mr. Finegold, for the committee on Public Service, on petition, a Bill relative to disability or death caused by infectious diseases, presumption (Senate, No. 1485);

Police and firefighters,--infectious diseases.

Read and, under Senate Rule 27, referred to the committee on Ways and Means.

By Ms. Rausch, for the committee on Municipalities and Regional Government, on petition, a Bill revising the town charter of Lunenburg (Senate, No. 2557) [Local approval received];

Lunenburg,-- town charter.

Read and, under Senate Rule 26, placed in the Orders of the Day for the next session.

Committees Discharged.

Ms. Lovely, for the committees on Rules of the two branches, acting concurrently, reported, asking to be discharged from further consideration

Of the Senate Bill establishing a special commission to study the noise effects of hunting migratory game birds in neighborhoods and communities within established coastal zones (Senate, No. 411);

Game birds,--hunting.

Of the Senate Bill relative to senior and non-elderly disabled housing (Senate, No. 2529);

Of the Senate Bill relative to attainable housing in seasonal communities (Senate, No. 2530);

Of the Senate Bill relative to equity in suicide prevention (Senate, No. 2610); and

Of the Senate Bill relative to a special commission on support group model integration in health care (Senate, No. 2611);

And recommending that the same severally be referred to the committee on Rules.

Under Senate Rule 36, the reports were severally considered forthwith and accepted.

Disabled housing,--senior.

Seasonal communities,--affordable housing. Suicide prevention,--commission. Support groups,--commission.

UNCORRECTED PROOF.

PAPER FROM THE HOUSE.

The House Bill to address challenges faced by municipalities and state authorities resulting from COVID-19 (House, No. 4598, amended),-- came from the House with the endorsement that the House had concurred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2619, with a further amendment by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4612.

COVID- 19,--municipal governance.

The rules were suspended, on motion of Mr. Rodrigues, and the House amendment was considered forthwith.

After remarks, Mr. Rodrigues moved that the Senate concur with the House amendment with a *still further amendment*, by striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2622.

The House further amendment, as amended, was adopted. Sent to the House for concurrence in the still further amendment.
