“Whereas, The deferred operation of this act would tend to defeat its purpose, which is to strengthen forthwith the local and regional public health system, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public health.”, *with a further amendment* by striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4671.

An engrossed Bill providing for virtual notarization to address challenges related to COVID-19 (see Senate, No. 2645, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.
