Monday, June 1, 2020

Met at eleven minutes past eleven o'clock A.M. (Mr. Timilty in the Chair).

The Chair (Mr. Timilty), members, guests and staff then recited the pledge of allegiance to the flag.

Petitions.

Petitions were severally presented and referred as follows:

By Mr. Brady, a petition (accompanied by bill) (subject to Joint Rule 12) of Michael D. Brady for legislation to allow restaurants to sell grocery items and other nondurable items during the COVID-19 pandemic;

By Mr. Tran, a petition (accompanied by bill) (subject to Joint Rule 12) of Dean A. Tran for legislation to establish a sick leave bank for Patrick Burns, an employee of the Department of Correction; and

By the same Senator, a petition (accompanied by bill) (subject to Joint Rule 12) of Dean A. Tran and Sheila C. Harrington for legislation to establish a sick leave bank for Nicholas Asselin, an employee of the Department of Correction.

Recess.

There being no objection, at twelve minutes past eleven o'clock A.M., the Chair (Mr. Timilty) declared a recess subject to the call of the Chair; and at three minutes before twelve o'clock noon, the Senate reassembled, Mr. Timilty in the Chair.

Matters Taken Out of the Orders of the Day.

The following matters were taken out of the Orders of the Day and considered as follows:

The House Bill to dissolve the Newburyport Redevelopment Authority and transfer its lands to the city of Newburyport (House, No. 4545),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence, its title having been changed by the committee on Bills in the Third Reading as follows: "An Act to dissolve the Newburyport redevelopment authority and transfer its lands to the city of Newburyport."

The House Bill authorizing the retirement board of the city of Salem to retire Brian Benson, a police officer of the city of Salem (House, No. 4621),-- was read a third time.

Pending the question on passing the bill to be engrossed, Ms. Lovely presented an amendment in section 1, by inserting after the word "non-taxable", in line 13, the following words:- "to the extent allowable under state and federal law".

The amendment was adopted.

The bill, as amended, was then passed to be engrossed, in concurrence, with the amendment.

Sent to the House for concurrence in the amendment.

Reports of Committees.

By Ms. Lovely, for the committees of Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Diana DiZoglio, Lenny Mirra, Patrick M. O'Connor, David F. DeCoste and others for legislation to temporarily expand take-out and delivery options for local establishments licensed to sell alcoholic beverages.

Senate Rule 36 was suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Consumer Protection and Professional Licensure.

By Ms. Lovely, for the committees of Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Julian Cyr and William L. Crocker, Jr. for legislation to establish a sick leave bank for William Marzilli, an employee of the Massachusetts Department of Transportation.

Senate Rule 36 was suspended, on motion of Mr. Tarr, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on Public Service.

Severally sent to the House for concurrence.

Mr. Rodrigues presented a motion that the Senate concur with the House amendment *with a further amendment* striking out all after the enacting clause and inserting in place there of the text of Senate document numbered 2733.

The motion prevailed and the Senate concurred in the House amendment with the further amendment.
