JOURNAL OF THE SENATE

Monday, June 15, 2020.

Met at seven minutes past eleven o'clock A.M. (Mr. Rush in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

PAPERS FROM THE HOUSE

Engrossed Bills.

The following engrossed bills (both of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Rush) and laid before the Governor for his approbation, to wit:

Establishing a sick leave bank for Marta Romero, an employee of the Department of Developmental Services (see House, No. 4691).

Matters Taken Out of the Orders of the Day.

The bill was read. There being no objection, the rules were suspended, on motion of Mr. O'Connor, the bill was read a second time and ordered to a third reading.

By Ms. Lovely, for the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the Senate petition of Joan B. Lovely and Bruce E. Tarr for legislation to transfer employees of the North Shore Regional 911 Center to the State 911 Department.

Senate Rule 36 was suspended, on motion of Ms. Lovely, and the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on State Administration and Regulatory Oversight.

By Ms. Lovely, for the committees on Rules of the two branches, acting concurrently, that the Senate Order, granting the committee on The Judiciary until June 30, 2020, within which time to make its final report on current Senate document numbered 2700, relative to Judiciary (Senate, No. 2758),-- ought to be adopted.

PAPERS FROM THE HOUSE.

The Senate Bill designating United States Cadet Nurse Corps Day (Senate, No. 2178, changed),-- came from the House passed to be engrossed, in concurrence with an amendment by adding the following section:

U.S. Cadet Nurse Corps Day.

"SECTION 2. The superintendent of the bureau of the state house shall, subject to the approval of the art commission of the state house as to size and content, install and maintain a plaque in a suitable space in Nurses Hall in the state house in honor of the Massachusetts members of the United States Cadet Nurse Corps."

The rules were suspended, on motion of Mr. O'Connor, and the House amendment was considered forthwith.

Mr. Tarr presented a motion that the Senate concur with the House amendment with a further amendment in section 2 (inserted by amendment by the House) by adding the following sentence:- "The Friends of the United States Cadet Nurse Corps WWII shall be responsible for the funding of the plaque."

The motion prevailed and the Senate concurred in the House amendment with

the further amendment.

Sent to the House for concurrence in the further amendment.

A Bill authorizing the Town of Lunenburg to grant an additional license for the sale of wines and malt beverages on the premises to Lanni Orchards (House, No. 4644,-- on House, No. 4365) [Local approval received on House, No. 4365],-- was read.

Lunenburg,-- liquor license.

There being no objection, the rules were suspended, on motion of Mr. Lovely, and the bill was read a second time and ordered to a third reading.

Adjournment in Memory of Joan Marie (Lynch) Sweeney.

The Senator from Essex, Ms. Lovely, moves that when the Senate adjourns today it do so in memory of Joan Marie (Lynch) Sweeney of Salem.

Joan Marie Sweeney passed away after a long illness on May 10th surrounded by her loving family.

Joan was born in Peabody in 1934 to the late Mary Rita and John Henry Lynch. Joan was three-sport athlete, multiple club member, vice-president, and graduated with highest honors.

In 1955, Joan graduated from Salem Hospital School of Nursing as a Registered Nurse. After her husband, John J. Sweeney, passed away in1973, she became a school nurse in order to spend more time with her children. She eventually rose to the position of Head Nurse of the Salem school system.

In addition to nursing, Joan worked with at-risk youth, for which the Social Advocates for Youth honored her with their Service and Dedication Award. Joan volunteered her time

with the Girl Scouts, Cub Scouts, and Boy Scouts, as well as at a teen drop-in center during the 1970's heroin crisis.

An avid reader, researcher, and published author, she investigated the history of her neighborhood and hometown. Joan was a member of Historic Salem, House of Seven Gables, Salem State University Explorers, Council on Aging Board, Mack Park Neighborhood Association, and Council on Aging Writers Group.

A recognized nurse, noted historian, determined advocate, quiet motivator, and sought-after mentor and advisor, Joan made a difference in many people's lives.

Joan is survived by her six children, Edward; Joan E. Brennan and her wife, Robin Woodman; John and his partner, Anne Rockwell; Joseph; Brian and his wife, Erin; and Robert; six grandchildren and five great-grandchildren. Joan was predeceased by her husband, John J. Sweeney and a daughter, Patricia M. Sweeney.
