Thursday, February 6, 2020.

Met at twenty-three minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

The Senate welcomed them with applause and they withdrew from the Chamber.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 2:00 P.M, on Monday, February 10, 2020. All such amendments shall be second reading-amendments to the Senate Ways and Means new draft (Senate, No. 2519), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

A message from His Excellency the Governor, returning with recommendation of amendment the engrossed Bill establishing additional powers for municipal light boards (see House, No. 4069) [for message, see House, No. 4253],— came from the House with

the endorsement that the House adopted the amendment recommended by the Governor (as approved by committee on Bills in the Third Reading), as follows:

By striking out all after the enacting clause and inserting in place thereof the following:

"Chapter 164 of the General Laws is hereby amended by inserting after section 55 the following section:-

Section 55A. A municipal light board may enter into an agreement with the city or town where it operates to provide billing, administrative, operational or other support services to assist the city or town with the operation of a municipal water utility owned and operated by the city or town upon such terms and conditions as agreed to by the city or town and the municipal light board."

The message was read; and, under the provisions of Article LVI of the Amendments to the Constitution, the bill was before the Senate subject to amendment and re-enactment.

The rules were suspended, on motion of Mr. O'Connor, and the amendment was considered forthwith and adopted, in concurrence.
