JOURNAL OF THE SENATE

Monday, August 3, 2020.

Met at six minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Boncore), members, guests and staff then recited the pledge of allegiance to the flag.

Engrossed Bill — Laid Before the Governor.

An engrossed Bill financing the general governmental infrastructure of the Commonwealth (see House, No. 4932) (which originated in the House), having been passed to be enacted and signed by the Acting President (Ms. Friedman) on Saturday, August 1, 2020 (being the legislative session of Friday, July 31, 2020),-- was laid before the Governor for his approbation on Monday, August 3, 2020.

*Adjournment in Memory of Peter Kopanon.*

The Senator from First Essex and Middlesex, Mr. Tarr, presented a request that when the Senate adjourns it adjourns in the member of Peter M. Kopanon, 91 of Essex, who passed away on June 1, 2020.

Peter was born in Gloucester on November 5, 1928, the son of the late Michael and Camille (Massura) Kopanon. He served in the U.S. Army in Munich, West Germany during the Korean Conflict, after which he joined the Registry of Motor Vehicles and retired in 1991 as the Deputy Registrar.

Peter was a resident of Essex for 65 years, taking enormous pride in looking after his home. He tended his vegetable gardens and apple trees, and over the years raised sheep, cattle, ponies, chickens, turkeys, geese, and bees. Until his death, he was known to work on several projects at once and rarely sat idle. He never failed to put aside whatever he was doing to help his friends, neighbors, and family. Peter was a true gentleman with a love of conversation, inherent curiosity, and boundless generosity.

Above all else, Peter's greatest joy was his family. He was predeceased by his wife Helen L. (Story) Kopanon with whom he shared fifty years of marriage. He is survived by his four children, eleven grandchildren, six great-grandchildren and two step-grandchildren. Peter is also survived by his sister, Stella Gallant of Winchester and brother, Nicholas Kopanon of Florida, many nieces and nephews and his beloved dog, Jocko. He was predeceased by his brothers, Christopher and A. Michael Kopanon.

Accordingly, as a mark of respect in memory of Peter Kopanon at one minute past one o'clock P.M., on motion of Mr. Tran, the Senate adjourned to meet again on Thursday next at eleven o'clock A.M.
