JOURNAL OF THE SENATE

Monday, September 28, 2020.

Met at twenty-six minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

Reports of Committees.

By Ms. Lovely, for the committees on Rules of the two branches, acting concurrently, to whom was referred the Senate Order granting the committee on The Judiciary until November 12, 2020, within which time to make its final report on current Senate documents numbered 313, 823, 825, 861, 899, 902, 937, 939, 978, 983, 989, 1041, 1209, 1385, 2457, 2480, 2571, 2644, 2815, 2818 and 2850, relative to Judiciary matters (Senate, No. 2885),-- ought to be adopted.

The rules were suspended, on motion of Mr. Tran, and, after remarks, the order was considered forthwith and adopted.

By Ms. Lovely, for the committees on Rules of the two branches, acting concurrently, that the Senate Order granting the committee on Public Health until October 2, 2020, within which time to make its final report on current Senate document numbered 2871, relative to plasma donation legislation (Senate, No. 2902),-- ought to be adopted.

The rules were suspended, on motion of Mr. Tran, and the order was considered forthwith.

Pending the question on adoption of the order, Ms. Comerford presented an amendment striking out the date "October 2, 2020" and inserting in place thereof: "October 17, 2020".

Engrossed Bills.

The following engrossed bills (both of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Collins) and laid before the Governor for his approbation, to wit:

Authorizing the town of Maynard to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (see House, No. 4693); and

Authorizing the town of Wellesley to continue employment of Jeffrey Peterson (see House, No. 4938).
