JOURNAL OF THE SENATE

Monday, October 19, 2020.

Met at eight minutes past eleven o'clock A.M. (Mr. Boncore in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Report of a Committee.

Emergency Preambles Adopted.

An engrossed Bill establishing a sick leave bank for Sharon L. Kelley, an employee of the trial court of the commonwealth (see Senate, No. 2867, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Sharon L. Kelley,--sick leave.

The bill was signed by the Acting President (Mr. Boncore) and sent to the House for enactment.

An engrossed Bill designating a certain bridge in the town of Sandwich as the Commander Francis T. Williams and Sandwich Veterans Memorial Bridge (see House, No. 4360, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Sandwich,-- bridge designation.

The bill was signed by the Acting President (Mr. Boncore) and sent to the House for enactment.

An engrossed Bill authorizing the Nauset regional school district to enter into renewable energy agreements (see House, No. 4830, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Nauset,-- renewable energy.

The bill was signed by the Acting President (Mr. Boncore) and sent to the House for enactment.

A Bill authorizing the town of Dedham to grant one additional license for the sale of beer and wine to be drunk on the premises (House, No. 5023,-- on House, No. 295) [Local approval received on House, No. 295],-- was read.

Dedham,-- liquor license.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A Bill authorizing the town of Dedham to grant additional licenses for the sale of all alcoholic beverages to be drunk on premises at Legacy Place (House, No. 5024,-- on House, No. 294) [Local approval received on House, No. 294],-- was read.

Dedham,-- liquor licenses.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

Engrossed Bills.

The following engrossed bills (the first two of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Boncore) and laid before the Governor for his approbation, to wit:
