The bill was read. There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

#### PAPERS FROM THE HOUSE.

The Senate Bill classifying the Taunton Fire Department mechanic, Michael Perry, in connection with the determination of retirement benefits (Senate, No. 2624),-- came from the House passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the following two sections:

Michael Perry,--retirement.

"SECTION 1. Notwithstanding chapter 32 of the general laws or any other general or special law to the contrary, Michael Perry, a member of the Taunton retirement system, shall have his pension calculated pursuant to subdivision (2) of section 5 of said chapter 32, utilizing the highest allowable percent as shown in the table contained within said section. If Mr. Perry applies for a disability retirement pursuant to section 7 of said chapter 32, he shall be deemed eligible for the provisions of section 94B of said chapter 32.

SECTION 2. This act shall take effect upon its passage."
