The Senator from Essex, Ms. Lovely, moved that when the Senate adjourns today, it adjourn in memory of John Henry Ronan.

John Henry Ronan, of Salem, Massachusetts, passed-away suddenly at his Salem home on November 19, 2020, at the age of 61.

John was born in Salem on August 2, 1959, the second of five children of the Honorable John T. and Marcia Ronan. He loved all sports passionately. He was educated at Hebron Academy in Maine, where he would develop a lifetime of close friends with whom he shared countless misadventures.

John attended Boston College and transferred to the University of Vermont where he swam competitively and graduated in 1982. In 1985, John graduated, cum laude, from Suffolk University Law School. His professional career started in Salem at the Essex County District Attorney's Office where he tried a wide variety of

criminal cases. He then entered private practice with Ronan, Segal and Harrington and later with Ronan & Holmes. He was appointed by Governor Charlie Baker to his position as General Counsel with the Department of Labor Standards in 2016.

John's laugh was legendary. He was most at home in the water. Anything John did, he overdid. He laughed too loud, worked too hard, played too hard, and loved his friends and family with wild passion. "Terrific" was how John would always answer the question "How are you?" – and he meant it.

A former Salem City Councilor, John was fiercely loyal to his hometown and loved all things Salem.

John is survived by his girlfriend, Sarah Calland, and his four siblings: Kelly Marchand of Concord, Mike of Swampscott, Jim of Marblehead, and Marcia Adams of Dorchester, NH, as well as their spouses and his wonderful nieces and nephews.

John is also survived by his best friend and son, John Henry Ronan, Jr.
