Thursday, January 21, 2021.

The bill was signed by the Acting President (Mr. Timilty) and sent to the House for enactment.

Engrossed Bill.

An engrossed Bill establishing a sick leave bank for George Monfreda, an employee of the Department of Mental Health (see House, No. 54, amended) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Timilty) and laid before the Governor for his approbation.

The Senator from Middlesex and Worcester, Mr. Eldridge, moved that when he Senate adjourns today it adjourn in memory of Antonio "Tony" Disc Chayes George Monfreda,-sick leave.

Bill laid before the Governor.

Antonio "Tony" Dias Chaves passed away on December 31, 2020 at the age of 71 after a brief but courageous battle with COVID-19. He was predeceased by his brother Abilio who passed on October 6th. Tony is survived by his wife of 41 years Zulia, his son Derek, several brothers and sisters, and many nieces and nephews.

Tony was born and raised in the Azores, Portugal where he made many lifelong friends. In 1967, he immigrated to the United States of America with his family, eventually settling in Hudson, Massachusetts. Tony enlisted in the Army during Vietnam, serving his country with pride and honor until 1972. In 1973, he started the Portugal 73 radio show with his close friends that ran until December of 2019 and was one of the oldest continually running Portuguese radio shows in the world.

In 1978, he became the first elected Portuguese selectman in Hudson and second elected in all of Massachusetts. Tony was awarded one of the highest civilian honors bestowed by the Portuguese Government, the Order of Merit.

Tony worked as a public servant for the Massachusetts Department of Public Health, the Department of Environmental Affairs, and the Office of Refugees and Immigrants. Tony would later work for the United States Department of Homeland Security as a TSA officer, and as a member of the TSA Honor Guard.

Tony loved his family and living life, and his legacy will live on through his contributions to his community.
