Adjournment in Memory of Margo Simon Golden.

The Senator from Suffolk, Ms. Chang-Diaz and the Senator from Suffolk and Middlesex, Mr. Brownsberger moved that when the Senate adjourns today it do so in honor of the memory of Margo Simon Golden of Boston.

Margo dedicated her life to public health and public service. Born and raised in Andover, Massachusetts, Margo was a graduate of Simmons College and obtained a Master's of Public Health from Boston University. Throughout her life, she worked and served at a variety of health organizations, from St. Elizabeth's Hospital, to the Watertown Health Center, to Beth Israel and Deaconess Hospitals, where she was a program director. Margo was also a member of the board of directors for the Women's Community Cancer Project and Alliance for a Healthy Tomorrow.

Above all her work in the field of public health, Margo leaves behind a formidable legacy at the Massachusetts Breast Cancer Coalition--the MBCC. In her nearly 10 years as Board President, from 2009 to 2018, Margo was a tenacious advocate for the MBCC's mission: not just to fight cancer, but to prevent its environmental causes. She helped craft an award-winning community education program focused on understanding and reducing exposure to environmental toxins, and she exemplified civic engagement, testifying at numerous hearings at the Boston City Council and the Massachusetts State House about environmental health risks and in support of funding for environmental research. At every level of the Massachusetts Breast Cancer Coalition, from interns and volunteers to staff and board members, Margo had a profound impact, and her work was noticed and

celebrated: in 2014, she was one of a hundred people honored by Massachusetts General Hospital for leading the fight against cancer.

From co-workers to friends, family, and loved ones, those who knew Margo spoke of her as exceptionally warm and kind, full of grace and strength. She was a committed and determined advocate for health and visionary leader in her work and for her community. All of us in Massachusetts are better off for Margo's deep dedication to creating a better, healthier world.

Margo is survived by her husband, Neil Golden, her children, Andrew Golden and his wife Kate Billman-Golem me, and Craig Golden, her grandson, Ellis, and her brothers, Donald Simon and his wife Susana de la Torre, and Gary Simon. Margo is also survived by Michael and Susan Golden, David and Beth Golden, and her nieces and nephews Elena and Eli Simon, Eric Golden, Sara Pell, Leah Kolodny, and Alena and Julia Golden.
