##### *Emergency Preambles Adopted.*

An engrossed Bill establishing a sick leave bank for Michael L. Rodrigues, an employee of the trial court of the commonwealth (see Senate, No. 15), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

**The bill was signed by the Acting President (Mr. Brownsberger) and sent to the House for enactment.**

The Senate Report of the Proposed Joint Rules for the 2021-2022 Legislative Session (Senate, No. 14),-- came from the House passed to be engrossed, in concurrence, *with an amendment* striking out all after the enacting clause and inserting in place thereof the text of House document numbered 68, as amended.

**Mr. Tarr moved that the Senate NON-concur in the House amendments and asked for a committee of conference on the disagreeing votes of the two branches; and Senators Lovely, Boncore and Fattman were appointed to the committee on the part of the Senate.**

**The bill was returned to the House endorsed accordingly.**

*Engrossed Bills.*

The following engrossed bills (both of which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Brownsberger) and laid before the Governor for his approbation, to wit:

Establishing a sick leave bank for Michael L. Rodrigues, an employee of the trial court of the commonwealth (see Senate, No. 15); and

Establishing a sick leave bank for Rachel Pride, an employee of the department of youth services (see Senate, No. 37).

Bills laid before the Governor.

The House Bill financing a program for improvements to the Unemployment Insurance Trust Fund and providing relief to employers and workers in the Commonwealth (House, No. 90),-- came from the House with the endorsement that the House had concurred in the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 38) *with a further amendment* striking out all after the enacting clause (inserted by amendment by the Senate) and inserting in place thereof the text of House document numbered 95.

Unemployment Insurance Trust Fund.

**The rules were suspended, on motion of Mr. Tarr, and, after remarks, the further House amendment was adopted, in concurrence.**

*Emergency Preamble Adopted.*

An engrossed Bill financing a program for improvements to the Unemployment Insurance Trust Fund and providing relief to employers and workers in the Commonwealth (see House, No. 90, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

**The bill was signed by the Acting President (Mr. Brownsberger) and sent to the House for enactment.**

*Adjournment in Memory of Lawrence Norton.*

The Senator from Norfolk and Plymouth, Mr. Keenan, moved that when the Senate adjourns today it adjourn in memory of Lawrence M. "Larry" Norton.

Larry Norton of Quincy, passed away suddenly on 20 October 2020, at the age of 76. Larry was born in Somerville and then moved to Quincy, where he lived for over 50 years. A recipient of the Purple Heart, Larry served with the United States Marines Corp in Vietnam.

Larry's service to the Marine Corp did not end in Vietnam. He made it his personal mission to ensure that the people of Quincy never forget the 48 soldiers from Quincy who lost their lives in Vietnam. Each year he organized dedications of memorial squares, in the

neighborhoods where each of the 48 lived, inviting family and friends, giving them closure, respect, dignity, and the comfort of knowing their loved ones would be forever remembered in Quincy.

Larry each year also organized a memorial service at the Vietnam War Memorial at Marina Bay. An active member of the American Legion, Larry served in a variety of capacities at both the state and national levels. He was a longtime member and past Commander of the Cyril P. Morrissette Post #294, and served as the Commander of the Quincy Veterans' Council. He was also the longtime president of the Quincy Chapter of the Vietnam Combat Veterans Combined Armed Forces.

Larry was truly one of a kind, outspoken and straightforward when it came to sharing his opinion and was a man of action and conviction. He was highly respected, and truly beloved.

Larry is survived by his wife Ruthie, his son Michael and wife Julie, daughter Pamela and her boyfriend Glenn Hermanson, and his son Kevin and wife Tara. He was the proud Pop to Mikey, Corbett and Shea. Brother of Kathie Brandt of Chicago, Illinois, and the late Paul Norton, Eleanor Trites, Louise Buckley, Thomas Norton and his surviving wife Joanne of Somerville, and Ann Eleanor (Nancy) Debonis.

So today, the Massachusetts State Senate adjourns in memory of Lawrence "Larry" Norton, remembered for his dedication to his beloved veterans and their families, his longtime service to the Quincy community, his endearing passion and candor, and his love of family. Semper Fi.
