*Adjournment in Memory of James Leo Trayers, Jr.*

The Senator from Norfolk, Bristol and Plymouth, Mr. Timilty, moved that when the Senate adjourns today it do so in memory of James Leo Trayers, Jr.

James Leo Trayers, Jr., of Milton, formerly of Dorchester, South Boston and Hyde Park passed away peacefully on February 3, 2021 after a courageous battle with cancer.

He was 75 years old.

Jimmy, as he was known, was the former owner and director of Scally and Trayers Funeral Home in Dorchester for 40 years. For 6 decades Jimmy devoted his life to the funeral business and took exceptional care of thousands of families in their time of need. Jimmy would often say of his career that “it wasn’t a job, but it was his life, his passion.”

Jimmy was born in South Boston and spent his formative years in Hyde Park where the Trayers Family continued to grow. After graduating from Catholic Memorial High School in 1963, Jimmy went onto the New England Institute for Mortuary Services where he graduated with distinction in 1967.

Alongside his uncle, John Connolly, and his father, Leo Trayers, Jimmy directed funerals from the J. J. Connolly and Son Funeral Home on Washington Street in Boston’s South End neighborhood until 1978 when he purchased Scally Funeral Home on Pleasant Street in Dorchester.

Jimmy was a past member of the Board of the Massachusetts Funeral Directors Association; member of The Neighborhood Club of Quincy; past member of the Milton-Hoosic Club, Puritan Canoe Club of South Boston, Falmouth Men’s Club, and The Ancient and Honorable Artillery Company, where he achieved the rank of Sergeant.
