Remarks of Barry R. Finegold.

375 years ago today, the General Court formally incorporated Andover as a town in Massachusetts. I wanted to say a few words in commemoration of Andover’s 375th anniversary:

Senator Barry R. Finegold,-- remarks.

As more people get vaccinated, our community can begin to recover from the pandemic and return to a more normal way of life.

The Town of Andover is planning some great events over the coming year, and I’m excited to get together with friends and neighbors in person.

Thanks so much to the members of the 375th Committee for all their hard work planning the festivities. I’d now like to read an official proclamation prepared by the Committee in honor of the 375th Anniversary:

Whereas, the Town of Andover in the Commonwealth of Massachusetts was incorporated and recognized as a Town on May 6, 1646 by the General Court of Massachusetts, this Proclamation, presented to the 192nd General Court of the Commonwealth of Massachusetts on Thursday, May 6, 2021 declares May 6, 2021 through May 6, 2022 as the official town wide celebration of Andover’s 375th Anniversary.

Whereas, past anniversaries have included a series of gala public events, historic gatherings, performances, amusements, soccer tournaments, golf events and more planned by past anniversary committees, the Committee for the 375th Anniversary is highlighting not only fun and enjoyment but educating our guests about our town's rich history.

Whereas, this proclamation hereby declares that the duties assigned by the Town of Andover to the 375th Anniversary Committee, and the committee's present course in meeting those goals, will provide for a successful kick off of the 375th Anniversary celebrations on May 6, 2021 and a most successful run over the ensuing 12-months.

The bill was read. There being no objection, the rules were suspended, on motion of Ms. DiZoglio, and the bill was read a second time and ordered to a third reading.

PAPER FROM THE HOUSE.

The House Bill financing the reconstruction of the Soldiers' Home in Holyoke (House, No. 3701),-- came from the House with the endorsement that the House had NON-

concurrred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2442, and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representatives Wagner of Chicopee, Gregoire of Marlborough and Berthiaume of Spencer had been appointed the committee on the part of the House.

On motion of Mr. Tarr, the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Friedman, Feeney and Fattman were appointed on the part of the Senate.

The bill was returned to the House endorsed accordingly.

Ordered, That notwithstanding any Special Rule of the Joint Session or any Senate or House Rule to the contrary, emergency rules adopted by and governing the branch in which a member serves shall apply for remote participation and voting in the joint session for members of each respective branch due to the 2019 novel coronavirus, also known as COVID-19 (Senate, No. 2446)

Under the rules, referred to the committee on Rules.

Subsequently, Ms. Lovely, for the said committee, reported, recommending that the order ought to be adopted and placed in the Orders of the Day for the next session.

The Senator from Berkshire, Hampshire, Franklin and Hampden, Mr. Hinds, presented a motion that when the Senate adjourns today it do so in memory of Mabel Hamilton.

UNCORRECTED PROOF.

Mabel Hamilton of Pittsfield passed away on Monday, April 26th at age 88. A longtime community leader, she leaves behind a lasting legacy of supporting and organizing community members whose voices were silenced.

Mabel was born in Mechanicville, New York and moved to North Adams as a girl. She recalled being the only African American student in her childhood classroom at the time. She then would move to Williamstown where she would see the Rev. Martin Luther King Jr. speak, a formative event in her life that lit a spark in her. She joined the NAACP and was honored by the organization with an award whose namesake was one of her longtime heroes, Shirley Chisholm. As an adult, she worked in Pittsfield to connect families with the local Head Start and Follow Through programs that support underserved children and their families. These programs closely aligned with Mabel's social justice work to close educational opportunity gaps. Mabel was a believer in community organizing and commanded respect through her work. The love she felt for those she met was unquestionable but she wasn't shy to speak frankly when she thought someone was headed down the wrong path. And when she spoke, everybody listened. Mabel cared deeply about, and advocated for, the needs of young people. She would go on to launch Action for Opportunity, a local employment training initiative, with the late Rev. Willard Durant of Price Memorial AME Zion Church. Mabel served as a mentor to a number of current Berkshire County community leaders, including Shirley Edgerton and Dennis Powell, both known for their leadership in supporting children and people of color in Berkshire County. Mabel and her family were longtime members of the Price Memorial AME Zion Church where she served as the congregation's Sunday school superintendent, deaconess, director of Christian outreach services, and lent her unforgettable vocals to the church choir. She will be missed by all.

Accordingly, as a mark of respect to the memory of Mabel Hamilton, at twenty-two minutes before one o'clock P.M., on motion of Mr. Tarr the Senate adjourned to meet again tomorrow at one o'clock P.M.
