*Adjournment in Memory of Officer Stephen M. Levesque*

The Senator from Essex and Middlesex, Mr. Tarr, and the Senator from Essex, Ms. DiZoglio, moved that when the Senate adjourns today, it does so in memory of Officer Stephen M. Levesque, 26, a member of the Rowley Police Department. Officer Levesque passed away at his home in Bradford on June 28, 2021. He was also a call firefighter for the town of Newbury.

Stephen was born on March 1, 1995 in Newburyport to Kathleen (Connolly) Levesque and the late William A. Levesque. Officer Levesque was raised in the village of Byfield in the town of Newbury and had a strong passion for serving his community and giving back. Stephen also enjoyed playing golf, going fishing, playing hockey and playing his guitar. An avid reader and he loved academics and constantly learning anything new. Stephen had recently completed his Masters thesis, "Carrying Trauma from Birth to Work: Adverse Childhood Experiences in Law Enforcement Officers and their Implications". Stephen was an animal lover as well, especially his two dogs, Archer and Abby. Stephen's greatest joy was being the "Master" of his grill.
