JOURNAL OF THE SENATE

Monday, August 2, 2021.

Met at seventeen minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The bill was signed by the Acting President (Mr. Collins) and sent to the House for re-enactment.

An engrossed Bill relative to parking fees on department of conservation and recreation roads (see House, No. 4010), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Regional tourism councils,-- grants.

The bill was signed by the Acting President (Mr. Collins) and sent to the House for re-enactment.

An engrossed Bill establishing a special legislative commission to study poverty in the Commonwealth (see House, No. 4016), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,—was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Poverty,-- special commission.

The bill was signed by the Acting President (Mr. Collins) and sent to the House for re-enactment.

Nursing home licensure,-- special commission.

An engrossed Bill establishing a higher education affordability task force (see House, No. 4018), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

Higher ed. affordability,-- task force.

The bill was signed by the Acting President (Mr. Collins) and sent to the House

for re-enactment.
