Peter Anthony Trucchi passed away on February 1, 2021 at the age of 79. He was born on October 4, 1941, in Taunton and was a lifelong resident of the city.

Peter is survived by the love of his life his wife of 58 years Marilyn Trucchi, their daughters Lori Kemmett and Lynn Deslauriers and their son Michael Trucchi, as well as his 6 grandchildren, and 5 great grandchildren. Peter was preceded in death by his parents John and Mable Trucchi, his brothers John and Edward Trucchi, along with his sisters Eleanor Nunes, and Arlene Corriveau.

Peter was a hardworking dedicated family man, loved and respected by all. He was a graduate of Monsignor James Coyle High school where he was an accomplished all star athlete. Many of Peter's cherished memories came from his high school years.

Peter had a persistent work ethic that began at a young age working side by side with his father John who founded the supermarket chain Trucchi's and Son. A butcher by trade, Peter loved his career and retired as meat department manager of Trucchi's Supermarket.

Peter served on the City of Taunton School Committee from January 1980 to December 1982, was a lifelong member and former president of the Italian Naturalization Club, a well-known member of the Italian Social Club of Taunton, and a member of the American Airforce Association.

He never missed a single game or event; he was their biggest fan and personal scorekeeper. Peter enjoyed playing bocce, was a competitive card player, and spent most of his free time taking long drives with his wife Marilyn.
