Monday, November 8, 2021.

Met at fourteen minutes past eleven o'clock A.M. (Mr. Timilty in the Chair).

Mr. Rodrigues offered the following order, to wit:

*Ordered*, That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill relative to immediate COVID-19 recovery needs (House, No. 4234) (the committee on Ways and Means having recommended that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2564) shall be considered for a second reading on Wednesday, November 10, 2021 and shall be the only item on the calendar.

Procedural order.

Upon adoption of this order, only redrafted and further amendments shall be in order. All amendments filed prior to this order and all redrafted and further amendments shall be second reading-amendments to the Senate Ways and Means new text (Senate, No. 2564), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

**The rules were suspended, on motion of Mr. O'Connor, and the order was considered forthwith and adopted.**

**The bill will be placed in the Orders of the Day for Wednesday, November 10, 2021, for a second reading with the amendment pending.**

*Adjournment in Memory of Alexandria "Lexi" Pinto.*

The Senator from Norfolk, Bristol and Plymouth, Mr. Timilty, moved that when the Senate adjourns today it do so in memory of Alexandria "Lexi" Pinto.

Alexandria "Lexi" Pinto, a talented 17-year-old Randolph resident who performed the song, "God Bless America" here at this very Rostrum in the Massachusetts Senate Chamber two years ago, passed away peacefully in her sleep on September 3rd. Lexi had been courageously battling a rare bone cancer, Chondroblastic Osteosarcoma, since her 14th birthday in 2018.

Lexi was born with a beautiful vocal talent, which catapulted her into delivering captivating performances of our National Anthem at a Boston Red Sox game in August of 2019, and at a Boston College basketball game in March of 2020. In each and every instance capturing the hearts of each and every person in attendance and listening on the airwaves.

As our favorite intern, Lexi with her infectious smile, would light up my office here at the State House, when she would visit.

Predeceased by her father, Antonio Pinto of Randolph, Lexi is survived by her mother, Darlene F. Pinto, and two brothers, Antonio Jr. and Jeremiah Pinto, both of Randolph; and many aunts, uncles and cousins.

Lexi also leaves a large community of people who loved her in both the town of Randolph and the city of Brockton. Moreover, Lexi also leaves, but will never be forgotten by, some very special friends that never left her side; especially but not limited to the members of the Randolph Police Department, the loving Randolph school community and her neighbors, especially Hanna and Mary Lou Burton.
