## Adjournment in Memory of William Giovannucci.

The Senator from Norfolk, Bristol and Plymouth, Mr. Timilty, moved that when the Senate adjourns today, it do so in memory of William "Billy" Giovannucci, a longtime resident of Milton and a founder of the Milton Gridiron Club, died on September 26, 2021, at Seasons Hospice Milton Inpatient Center, in the comfort of his loving family. He was 52 years old.

Known as "Gio" to his close circle of friends, Billy was remarkably adept at including people from all types of backgrounds into everything in which he was involved. To his buddies, he was like a big brother, someone that we all looked up to and still do.

Moreover, Gio had an innate ability to connect with people. He was never one to pass judgment on people and he always found the positive qualities in everyone that he met. Gio made each individual that he encountered feel important.

Gio was born in Quincy, raised, and educated in Milton. Gio and I both attended together the Village Nursery School and Pierce Elementary School, remaining lifelong friends.

Additionally, Gio graduated from Milton High School in 1987. Here he played on the varsity football team as a starting offensive lineman. Moreover, Gio was named as a Bay State League Football All-Star his senior year.

Furthermore, he was also a graduate of the University of Massachusetts Amherst.

Demonstrating both his love of athletics and his loyalty to Milton High School, Gio, along with several Milton High School Football Alumni from the Classes of '86, '87, '88, went on to form the Milton Gridiron Club in 2012, in support of the Milton High School program, players, cheerleaders, managers, and coaches.

Furthermore, Gio loved coaching his twin daughters, Delia and Sienna, in their various sports and was a well-known coach in the Milton Girls Softball League for twenty years. Here, he served on the Milton Girls Softball League executive board. In addition, he was a driving force behind obtaining the score boards that now stand today. In a tribute to Gio by the League, the board stated that "the players' experience in the league is better due to Gio's efforts. From bullpens to fences to foul poles to anchored bases to hot dogs at all-star games and opening day, Gio did it or had a hand in it. Milton and the softball league are better off because of his efforts."

Gio bravely battled colon cancer for more than four years. During this battle, Gio did his best to forge ahead and never slow down. It was a year ago this December that he was able to travel with his friends Greg Lane, Jim Tracy, and Jim Quinn to the Grand Canyon National Park. Together, Gio and his friends, hiked into the canyon, stayed outside camping for two nights, before undertaking a grueling hike back to the top. He was so proud of this remarkable achievement. Yet, Greg, Jim Tracey, and Jim Quinn were even

Equally important to Gio, was his love of Karate. He joined his first dojo at the age of 14. Remarkably, he recently earned his Eighth Degree Black Belt, an achievement that can take some students upwards of 50 years to accomplish. Gio once wrote about Karate instruction: "You share what you know, study what others can show you, and try to map out the common denominators that help make anyone better. When we can recognize and articulate principals to yourself, then ego and window dressings fall away. You know exactly what of the physical world you are trying to utilize in your art, in the daily fights of life. Principals don't change."

Most of all, Bill was devoted to his family and was especially proud of his twin daughters, supporting all their many activities and accomplishments.

He was employed for 25 years with Simsbury Associates of Hingham. Here, Gio served as vice-president and project manager.

Gio is best summed up as an incredibly content and pleasant person who imparted a calming influence on those around him, was a loyal friend, devoted family man, and never sought out attention for himself.

Bill is survived by his beloved wife of twenty years, Marianne (Kintigos) Giovannucci, his twin daughters, Delia and Sienna Giovannucci, both of Milton, his loving parents, William "Joe" and Paula (Mulroy) Giovannucci of Weymouth, his siblings, John Giovannucci and Cory of Quincy, and the late Laura A. Boulay.

Gio was the son-in-law of Joseph F. Kintigos of Quincy and his late wife Mary A. (Ridge) Kintigos. In addition, he was the brother-in-law of Joseph F. Kintigos, Jr., Mark A. Kintigos, both of Quincy, and the late Eileen Kintigos.

Bill is also survived by several nieces, nephews, one cousin, and legions of friends who will forever admire and love him.
