JOURNAL OF THE SENATE

Monday, January 10, 2022.

Met at a quarter past eleven o'clock A.M. (Mr. Lewis in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Lewis), members, guests and staff then recited the pledge of allegiance to the flag.

Malia for an investigation by a special commission (including members of the General Court) relative to health insurance coverage for medically necessary treatment in public schools,-- and recommending that the same be referred to the committee on Health Care Financing;

Of the committee on Municipalities and Regional Government, asking to be discharged from further consideration

Of the petition (accompanied by bill, House, No. 2145) of Mike Connolly relative to promoting the adoption of renewable energy for heating, cooling and hot water under the zoning law; and

Matters Taken Out of the Orders of the Day.

The House Bill authorizing the division of capital asset management and maintenance to convey a certain parcel of land to the Claremont Realty Trust in the city of Framingham (House, No. 4252) (its title having been changed by the committee on Bills in the Third Reading),-- was read a third time and passed to be engrossed, in concurrence.

The House Bill relative to bidding requirements for a certain affordable housing project in the town of Brookline (House, No. 4083),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

The bill (Senate, No. 123) will be placed in the Orders of the Day for Thursday, January 13, 2022 for a second reading, with the amendment pending.

Ms. Lovely, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The Senate Bill naming the Global War on Terror Memorial Bridge in the town of Ipswich (Senate, No. 2380).

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

Mr. Rodrigues, for the committee on Ways and Means, to whom was referred the Senate Bill to provide identification to youth and adults experiencing homelessness (Senate, No. 2276),- reports, recommending that the same ought to pass with an amendment substituting a new draft with the same title (Senate, No. 2612).

Order Adopted.

Mr. Rodrigues presented the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, Senate Bill to provide identification to youth and adults experiencing homelessness (Senate, No. 2276), shall be placed in the Orders of the Day for a second reading on January 13, 2022 with the amendment pending.

The rules were suspended, on motion of Mr. Rodrigues, and the order was considered forthwith and adopted.

The bill will be placed in the Orders of the Day for Thursday, January 13, 2022, for a second reading with the amendment pending.

PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 4323) of Mathew J. Muratore and Susan L. Moran for legislation to establish a sick leave bank for Charles H. Bletzer, an employee of the Trial Court,-- was referred, in concurrence, under suspension of Joint Rule 12, to the committee on the Judiciary.

Engrossed Bills.

An engrossed Bill validating the actions taken at the annual town meeting and a certain special town meeting in the town of Rowley (see Senate Bill, printed in Senate, No. 2550) (which originated in the Senate), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted, two-thirds of the members present having voted in the affirmative, and it was signed by the Acting President (Mr. Lewis) and laid before the Governor for his approbation.

The following engrossed bills (both of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Lewis) and laid before the Governor for his approbation, to wit:
