Mr. Rodrigues presented the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the Senate Bill relative to pharmaceutical access, costs and transparency (Senate, No. 771) (the committee on Ways and Means having recommended that the bill be amended by substituting a new draft, Senate, No. 2651) shall be placed in the Orders of the Day for a second reading on Thursday, February 10, 2022.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 3:00 P.M. on Monday, February 7, 2022. All such amendments shall be second reading-amendments to the Senate Ways and Means new draft (Senate, No. 2651), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

The rules were suspended, on motion of Mr. Rodrigues, and the order was considered forthwith and adopted.

The bill will be placed in the Orders of the Day for Thursday, February 10, 2022, for a second reading with the amendment pending.

PAPERS FROM THE HOUSE.

The Senate Bill fostering voter opportunities, trust, equity and security (Senate, No. 2554),-- came from the House passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the text of House document numbered 4367; and by inserting before the enacting clause the following emergency preamble: "Whereas, The deferred operation of this act would tend to defeat its purpose, which is to authorize forthwith voter opportunities, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

Mr. Tarr moved that the Senate NON-concur in the House amendments and asked for a committee of conference on the disagreeing votes of the two branches; and Senators Finegold, Creem and Fattman were appointed to the committee on the part of the Senate.

The bill was returned to the House endorsed accordingly.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill making appropriations for the fiscal year 2022 to provide for supplementing certain existing appropriations and for certain other activities and projects (see House, No. 4345, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Collins) and sent to the House for enactment.

Subsequently, the bill, which originated in the House, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Mr. Collins) and laid before the Governor for his approbation.
