Adjournment in Memory of John J. "Boots" Connelly.

The Senator from Norfolk, Bristol and Plymouth, Mr. Timilty, the Senator from Norfolk and Suffolk, Mr. Rush and the Senator from Plymouth and Barnstable, Ms. Moran, moved that when the Senate adjourns today, it adjourns in memory of John J. "Boots" Connelly, a lifelong resident of West Roxbury and Milton, who passed away on Christmas Eve, 2021, at the age of 86.

Boots, a member of the Class of 1954 at Boston Latin, had a legendary athletic career in his school days. For instance, he was a three-sport captain in football, baseball, and hockey. Moreover, Boots was honored as an All-Scholastic athlete during his illustrious high school career. Eventually, Boots' athletic excellence would be recognized with his overwhelming induction into the Boston Latin School Hall of Fame.

Additionally, Boots attended Boston College. Here, he starred in both football and baseball. Furthermore, Boots served as the vice president of the Class of 1958.

After an outstanding four years of achievement both on and off the field, Boots answered the call to service and was commissioned as an officer in the United States Marine Corps in 1959. After being honorably discharged from the Marine Corps, Boots was appointed to the position of probation officer in the Boston Juvenile Court. Eventually, he was promoted to Chief Probation Officer, assigned to Norfolk County Probate and Family Court in 1971. Here, he served with fidelity and distinction, until his retirement in 2009.

Above his myriad of professional and athletic accomplishments, Boots was most proud of his entire family, enjoying many wonderful occasions over the years. Specifically, Boots treasured his summers in Scituate with his beloved family. In his later years, he had a wonderful retirement with his wife, Marilyn, celebrating family milestones, traveling, and enjoying friendships at his Fuller Village residence.

Boots met his wife, Marilyn in Scituate. A resident of Arlington, he affectionately referred to here as "Arlington's Finest."

John is survived by his loving wife of sixty-two years, Marilyn (Kenny) Connelly.

He was the proud father of Dr. Maureen Connelly and her husband, Dr. Jeffrey Krane, John Connelly, Catherine Connelly-Perry and her husband Jim Perry, Michael Connelly and his wife Noreen, Honorable Kevin Connelly and his wife Mosey, and Susan Singer and her husband Sam.

He is survived by 12 very special grandchildren, as well as many nieces and nephews, and legions of admiring friends.

Boots will be greatly missed by all the friends, family, classmates, teammates, and colleagues who were blessed to have known him.
