Thursday, May 19, 2022.

Met at eighteen minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Collins), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Collins) handed the gavel to Messrs. Timilty and Brady for the purpose of an introduction. Mr. Timilty then introduced the Oliver Ames High School Girls Basketball Team. The team was recognized for winning the Massachusetts Interscholastic Athletic Association Division 2 State Championship against the undefeated number 1 seed Norwood, with a score of 53-48 at the Tsongas Center. The Tigers have been led by Coach Laney Clement-Holbrook, who is retiring after more than 40 years of coaching and serving as a mentor to the student athletes. The team was applauded for their accomplishments and withdrew from the Chamber. They were also accompanied by Assistant Coaches Brittney Engle and Christine Hochstein and Principal Kelly Cavanaugh. They were also guests of Representative Cassidy of Brockton.

There being no objection, the Chair (Mr. Collins) introduced, in the rear of the Chamber, Tom Harrington who was visiting from Ireland. The Senate welcomed him with applause, he signed the guestbook and he withdrew from the Chamber.

PAPERS FROM THE HOUSE.

The House Bill regulating sports wagering (House, No. 3993),-- came from the House with the endorsement that the House had NON-concurred in the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2682), and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representatives Parisella of Beverly, Michlewitz of Boston and Muradian of Grafton had been appointed the committee on the part of the House.

Sports wagering.

On motion of Mr. Tarr, the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Rodrigues, Lesser and

O'Connor were appointed on the part of the Senate.

The bill was returned to the House endorsed accordingly.

The House Bill relative to work and family mobility (House, No. 4470),-- came from the House with the endorsement that the House had NON-concurred in the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2872), and had asked for a committee of conference on the disagreeing votes of the two branches; and that Representatives Straus of Mattapoisett, Devers of Lawrence and Xiarhos of Barnstable had been appointed the committee on the part of the House.

On motion of Mr. Tarr, the Senate insisted on its amendment and concurred in the appointment of a committee of conference; and Senators Crighton, Lovely and Fattman were appointed on the part of the Senate.

The bill was returned to the House endorsed accordingly.

Engrossed Bills.
