The President in the Chair, a report of the committee of conference of the disagreeing votes of the two branches, with reference to the Senate amendments to the House Bill expanding protections for reproductive rights (House, No. 4594) (*amended by the Senate* by striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 3003; and by striking out the emergency preamble and inserting in place thereof the following: “Whereas, the deferred operation of this act would tend to defeat its purpose, which is to expand protections for reproductive and gender-affirming care, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.”; and by striking out the title and inserting in place thereof the following title “An Act expanding protections for reproductive and gender-affirming care”),-- reported, a “Bill expanding protections for reproductive and gender-affirming care” (House, No. 5090),-- came from the House, and was read.

The rules were suspended, on motion of Ms. Creem, and the report was considered forthwith.
