Thursday, June 16, 2022.

Met at seventeen minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

The House Bill financing the general governmental infrastructure of the Commonwealth (House, No. 4807),-- was read a second time.

After remarks, pending the question on adoption of the amendment previously recommended by the committee on Ways and Means (striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2926) and pending the question on ordering the bill to a third reading, the Senate considered several amendments.

There being no objection, the following amendments were considered as one, and *rejected* as follows:

Mr. Tarr moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$400,000 shall be expended for the planning, design and construction of a central fire station in the city of Gloucester"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,400,000".

The amendment was rejected.

Mr. Hinds moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "provided further, that not less than \$30,000,000 shall be expended for renovations, improvements, and demolition to Mark Hopkins Hall, Eldridge Hall, and the Freel Library at the Massachusetts College of Liberal Arts in North Adams"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$31,000,000".

The amendment was rejected.

Mr. Hinds moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$2,000,000 shall be expended to Jacob's Pillow for renovations to the Ted Shawn Theatre"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$3,000,000".

The amendment was rejected.

Ms. Moran and Mr. Cyr moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$125,000,000 shall be expended to expand broadband internet access in Barnstable County"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$126,000,000".

The amendment was rejected.

Mr. Tarr moved that the proposed new text be amended by inserting in line 286 after 1 the word "vessels" the following:- ", gear".

The amendment was rejected.

Mr. Feeney moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$300,000 shall be expended for the design and improvements to the old town hall in the town of Walpole"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,300,000".

The amendment was *rejected*.

Ms. Chang-Diaz moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$75,000 shall be expended in equal parts to JP Centre/South Main Streets, Egleston Square Main Street, and Three Square Main Street JP for business generating technology for Jamaica Plain Businesses"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,075,000".

The amendment was rejected.

Ms. Chang-Diaz moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$400,000 shall be expended to the Boston Public Schools for the purchase and installation of facility infrastructural and equipment needs, updates, and expansions to support school-based Adult Career Technical Education for Boston's formerly incarcerated individuals and court-involved youth"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,400,000".

The amendment was rejected.

Mr. Feeney moved that the proposed new text be amended in section 2C, in line item 0640-1005, in line 234, by inserting after the word "waste" the following words:- "; provided that funds shall be expended for the dredging of the Ten Mile River to halt flooding impacting Attleboro, North Attleborough, Plainville and Seekonk".

The amendment was rejected.

Ms. Chang-Diaz moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$500,000 shall be expended to Boston Housing Authority for grants to urban neighborhood-based food pantries, food coops, urban farms, and urban food forests serving BHA residents"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,500,000".

The amendment was rejected.

Mr. Cyr moved that the proposed new text be amended in section 2B, in item 7004-0067, after the words "General Laws" in line 200, by adding the following words:- ", and including a grant program for communities that experienced an increase in median home price of eighteen-percent or more in calendar year 2020 to 2021; and provided further, that funds in this item shall be distributed in a manner that promotes geographic equity"; and by striking out the figure "\$25,000,000" and inserting in place thereof the following figure:- "\$30,000,000".

The amendment was rejected.

Mr. Feeney moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$125,000 shall be expended for ADA compliant accessibility upgrades to the Mason Field House in the town of North Attleborough"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,125,000".

The amendment was rejected.

Mr. Feeney moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$150,000 shall be expended for the construction of a playground at Amvet Boulevard elementary school in the town of North Attleborough"; and by striking out the figure "\$1,000,000" and inserting in place thereof the following figure:- "\$1,150,000".

The amendment was rejected.

Ms. Jehlen and Mr. Lesser moved that the proposed new text be amended in section 2B by adding the following item:-

"xxxx-xxxx For the first year of the Small Properties State Acquisition Funding Pilot as part of the Housing Stabilization and Investment Trust Fund established in section 2 of chapter 121F of the General Laws; provided, that this program shall issue soft loans to supplement other acquisition soft loans administered by municipal or other affordable housing acquisition lenders on a rolling basis; provided further, that acquisitions pursuant to this program shall follow the affordability restrictions of said affordable housing acquisition lenders; provided further, that loans under this program shall be used for the acquisition of buildings of no less than 1 unit and no more than 123

Mr. Lewis moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that not less than \$500,000 shall be expended for flood mitigation of the Mystic River;"

The amendment was rejected.

Mr. Montigny moved that the proposed new text be amended in section 2, in item 1100-2516, by adding the following words:- "; provided further, that the unexpended balance in item 7002-1120, as authorized pursuant to chapter 228 of the acts of 2018, shall be made available to Northstar Learning Centers, Inc. to design and construct an early childhood education center in the city of New Bedford to benefit financially disadvantaged children and families".

The amendment was rejected.

(b) Annually inventory the professional licenses and certifications available for those who work in the mental health and addiction treatment field, including, but not limited to, the number of licensed and certified individuals in the state, the academic and supervisory requirements to achieve each certification, the scope of practice of each license, the academic programs available in the state and cost of these programs.

(c) Annually create demographic profiles of the current field of practitioners.

(d) Annually inventory the number of professional and paraprofessional practitioners delivering direct clinical or recovery services, including practitioner acceptance of insurance.

(e) Work with the advisory committee established herein to annually inventory the workforce needs in the behavioral health system to establish the gaps that exist by professional license and certificate, and practice settings.

(f) Inventory the number of individuals with professional licenses or certifications who no longer practice behavioral health in third-party reimbursable settings.

(g) Examine any regulatory changes recommended by licensing and registration entities at the Division of Professional Licensure, and the Department of Public Health, and offer public written assessments to these entities during the regulatory process that includes the effect of these requirements on the existing workforce and the future workforce pipeline.

(h) Examine existing training funds across state and federal agencies, including but not limited to, the Executive Office of Labor and Workforce Development, the Commonwealth Corporation, the Executive Office of Education, the Executive Office of Health and Human Services and its constituent agencies, and make recommendations on ways to leverage funding and resources to focus on existing and needed training programs for the field.

(i) Work with existing education and training programs on curriculum improvements focused on best practices in the current behavioral health landscape and coordinate these needs with state purchasing agencies to better align educational institutional institutions with the needs in the field.

(j) Examine existing loan forgiveness opportunities for practitioners and make recommendations on ways to expand current initiatives.

(k) Establish an advisory committee, to be cochaired by a person appointed by the Department of Higher Education and a person appointed by the Association for Behavioral Healthcare, and members selected by the commissioner, including, but not limited to, representation from each of the following entities: the Executive Office of Health and Human Services, the Department of Public Health, the Department of Mental Health, the Blue Cross and Blue Shield of Massachusetts, the Massachusetts Association of Health Plans, the Executive Office of Labor and Workforce Development, NAMI Massachusetts, the Massachusetts Organization for Addiction Recovery, the Parent Professional Advocacy League, the Massachusetts Association for Behavioral Health Systems, the National Association of Social Workers-Massachusetts, the Massachusetts Psychological Association, the Massachusetts Mental Health Counselors Association, and the Massachusetts for Mental Health. The advisory committee shall meet regularly and discuss the state of the behavioral workforce in Massachusetts.

(1) Create and fund a technical assistance center that funds special projects and assistance for value-based purchasing and care preparation and behavioral health and primary care integration.

(m) Examine other matters deemed appropriate by the Center."

Adjournment in Memory of Sarah Etelman.

The Senator from Hampshire, Franklin and Worcester, Ms. Comerford, moved that when the Senate adjourns today, it do so in memory of Sarah Etelman.

Sarah Etelman – beloved by many – died on June 3 following a courageous, threeyear battle with pancreatic cancer. Sarah was just 53 years old – taken too soon from those who loved and admired her. I offer this closing in partnership with Representative Dan Carey, with whom I share the representation of South Hadley.

Across western Massachusetts – and beyond – people are mourning Sarah who served on South Hadley's Selectboard since 2013 and was Vice Chair when she died, chaired South Hadley's Democratic Town Committee, volunteered on local nonprofit boards, and worked at regional nonprofits for decades.

Most recently, Sarah was honored with the Dream Maker Award by Girls Inc. of the Valley where she led the work to raise funds to support the organization's mission of making girls strong, smart, and bold.

Girls Inc. Executive Director said of Sarah, "Sarah was a strong advocate for girls, a smart, committed member of the Girls Inc. team for twelve years. Her activism around diversity, equity and inclusion for girls' growth and development was nothing short of inspirational."

Sarah is remembered by family, friends, co-workers, and her community as kind, creative, whip-smart, unabashedly distinctive, and as a champion for local businesses and farmers markets. Her heart was fierce, and her humor and wit were endless.

South Hadley Democratic Town Committee Chair, Susan Newton said of Sarah, "Our Commonwealth and the Town of South Hadley lost one of its brightest lights with the

passing of Sarah Etelman. Sarah didn't let the bully that is cancer stop her from continuing to work on behalf of South Hadley residents, nor did she step back from her continued mentoring of other female candidates for public office. She served until she simply couldn't, and well past when many would have turned to their own interests. Sarah's legacy includes a stronger South Hadley, and for those of us she leaves behind – buoyed by Sarah's incredible bravery – a renewed commitment to fight for the good and help vanquish the bad."

Sarah grew up in Wayland and attended Ithaca College. She is survived by sisters Carla Schine and Paula Webb, cousins Faith and Julia Michaels, Uncle Fred Wilcon, and countless community members who mourn her loss and celebrate her extraordinary life.

The ultimate optimist mixed with her own brand of pragmatism, in her biography on the Girls Inc. website, Sarah wrote that Dolly Parton headlined the first concert she ever attended, and that she embraced Parton's life philosophy: "If you want to see the rainbow, you've gotta put up with the rain."

Sarah lived life out of the box. Her favorite color was purple because – of course – she wouldn't be a primary color. She would choose her own unique style.

Fellow South Hadley Selectboard member, Andrea Miles, said of Sarah, "She was more than politics. She was a gifted artist and a joyful audience of musicals and shows. She loved her friends like family and treasured her cats. In honor of Sarah's life, I encourage us to shop local, wear purple, go for a walk, or enjoy a chocolate martini (her favorite). Above all of that, register to vote and help someone else register to vote. That would be a legacy she'd love."

Accordingly, as a mark of respect to the memory of Sarah Etelman, at twenty-eight minutes before four o'clock P.M., on motion of Mr. Tarr, the Senate adjourned to meet again on Tuesday next at eleven o'clock A.M.
