### Matters Taken Out of the Orders of the Day.

Authorizing the town of Millbury to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises (see Senate, No. 2477);

Exempting Marcel Cuffy and John R. Baker from the maximum age requirements for firefighters in the town of North Andover (see Senate, No. 2498);

Authorizing the town of Mansfield to grant additional licenses for the sale of all alcoholic beverages to be drunk on the premises (see Senate, No. 2591);

Further regulating the filling of vacancies on the city council of the city of Springfield (see House, No. 4223); and

Directing the police department of the city of Boston to waive the maximum age requirement for police officers for Daniel Flores (see House, No. 4233).

A petition (accompanied by bill, House, No. 4787) of Michael J. Finn relative to child welfare protections,-- was referred, in concurrence, under suspension of Joint Rule 12, to the committee on Children, Families and Persons with Disabilities.
