The House Bill authorizing the commissioner of capital asset management and maintenance to convey a certain parcel of land to the city of Fitchburg (House, No. 4902) (its title having been changed by the committee on Bills in the Third Reading),-- was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Cronin presented an amendment in section 1 by inserting after the first sentence, the following sentence:- "The conveyance shall include a historic covenant on the deed."

Adjournment in Memory of Robert S. Salvo, Sr.

The Senator from Bristol and Norfolk, Mr. Feeney, moved that when the Senate adjourns today it do so in memory of Robert S. Salvo, Sr. also known as "Bobby", of Norton, Massachusetts.

Bobby Salvo passed away unexpectedly on June 21, 2022 at the age of sixty-three. He will be dearly missed by his wife of nearly 41 years, Dawn M. Salvo, his children

(Ryan, Robert Jr., and Courtney, and their spouses), his brothers and sisters, and his 7 grandchildren (Dante, Paisley, Brayden, Brody, Elliana, Kinsley and Blake), whom he

loved dearly.

Born on December 28, 1958 in Stoughton to his late parents John and Helen, Bobby grew up in Easton and later made his home in Norton, where he raised his family and proudly founded S & L Construction, a family business he owned and operated for thirty-five years.

A distinguished public servant and well-known member of the community, Bobby was involved in numerous town organizations. He was a longtime member of the Norton Housing Authority, and formerly served as a member of the Norton Recreation Commission and Norton Lions Club. He also served as a Norton Call Firefighter and a Special Police Officer in the Town of Easton. Most notably, he will be remembered for serving 15 years on the Norton Select Board where he cemented his legacy as a pragmatic and dedicated public servant.

In an article published by Sun Chronicle columnist Bill Gouveia, Bobby's service to the town was summarized best:

"He did not promote himself or seek to glorify his own service. Bobby was someone that "did the job" and didn't seek to be recognized for that accomplishment. He was not flashy in his local politics, did not seek to stand out or get his name in the newspaper. He wasn't who you went to for a controversial quote or criticism of his fellow officials.

Bobby Salvo was one of those folks who just did the work, just did his job."

In his spare time, Bobby cultivated many hobbies including cooking, grilling, gardening, and motorcycling. Though above all else, Bobby most enjoyed spending time with his loving family and cherished being a grandfather to his 7 adoring grandchildren, who were the twinkle in his eye.

Bobby has been a fixture of the Norton community for many years, and his passing has left a void in the hearts of all who knew him. He will be missed dearly by his family and friends, and will be remembered for the many contributions he made to the Norton community.

Robert Salvo served with humility and was truly a man for others.

Accordingly, as a mark of respect to the memory of Robert S. Salvo, Sr, at fourteen minutes past eleven o'clock AM., on motion of Mr. O'Connor, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
