## JOURNAL OF THE SENATE

Monday, October 24, 2022.

Met at ten minutes past eleven o'clock A.M. (Ms. Friedman in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Ms. Friedman), members, guests and staff then recited the pledge of allegiance to the flag.

## Distinguished Guests.

There being no objection, the Chair (Ms. Friedman) handed the gavel to Mr. Timilty for the purpose of an introduction. Mr. Timilty then introduced, in the rear of the Chamber, the Ukrainian National Rowing Team. The team is in Boston having competed, for the first time, in the renowned Head of the Charles Regatta this past weekend. The athletes were recognized for having placed 9th out of 90 in the Men's Youth 4, 12th out of 25 in the Men's Championship 8 and 9th out of 29 in the Woman's Championship. The group is also proudly serving as cultural ambassadors for Ukraine, demonstrating the strength and perseverance of the Ukrainian people and their nation. Also among the group was Andrii Ivanchuk, a former member of Ukraine's national team, now head crew coach for Simmons University, who was instrumental in bringing this team to Boston to compete. The Senate applauded their accomplishments and they withdrew from the Chamber.

#### Emergency Preambles Adopted.

Ms. Friedman in the Chair, an engrossed Bill authorizing the Division of Capital Asset management and Maintenance to convey a certain parcel of land to the school department in the city of Westfield (see House, No. 5156, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 4 to 0.

The bill was signed by the Acting President (Ms. Friedman) and sent to the House for enactment.

An engrossed Bill establishing a sick leave bank for Molly Urquhart, an employee of the department of children and families (see House, No. 5230), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 4 to 0.

The bill was signed by the Acting President (Mr. Friedman) and sent to the House for enactment.

By striking out, in line 665, the figure "100" and inserting in place thereof the following words:- "Not less than 100"; and

By inserting after the word "voters", in line 708, the following words:- "voting in such election".
