JOURNAL OF THE SENATE

Thursday, October 20, 2022.

Met at seven minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Adjournment in Memory of Cassandra Jerome.

The Senator from Norfolk and Suffolk, Mr. Rush, presented a request that that when the Senate adjourns today it do so in memory of Cassandra Jerome of Norwood.

Cassandra Jerome unexpectedly passed away on September 14, 2022 at the age of 39. Ms. Jerome made an impact as a social worker with the Massachusetts Department of Children and Families. For nearly seven years she served the Boston, south shore and south coast regions as a member of Department of Children and Families, the most recent three years as an adolescent worker. Ms. Jerome used her voice to advocate for her coworkers and bring attention to issues of racial inequality and discrimination in the workplace. Her advocacy contributed to a healthier and more diverse workplace.

Always facing challenges with a smile on her face and quick joke, Ms. Jerome is described as a "firecracker" and "good human" by her peers. The love of her family, her husband and her children were always her driving force. She was dedicated to her clients and went above and beyond ensuring they received proper services, attention, and time.

Ms. Jerome is survived by her husband Princeton Hunt, children Xavier and Jovanni, and parents Duvane Dubuisson and Louis Jerome.
