JOURNAL OF THE SENATE

Thursday, November 17, 2022.

Met at five minutes past eleven o'clock A.M. (Mr. Crighton in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Students from the third-grade class from the Pine Hill Elementary School in Sherborn led the Chair (Mr. Crighton), members, guests and staff in the recitation of the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Crighton) handed the gavel to Mr. Collins for the purpose of an introduction. Mr. Collins then introduced, in the rear of the Chamber, a group of Irish dignitaries. Among the group was Michael Heaney of Donegal, Ireland. Mr. Heaney is the Director of Services with Donegal County Council with specific responsibility for Community, Culture, Planning & Economic Development. He was recognized for his dedication to promoting the ongoing partnership between Ireland and the United States. He addressed the Senate from the Rostrum, was presented a Senate and Governor's Citation, signed the guest book and withdrew from the Chamber. He was accompanied on the Rostrum by the Mayor of Donegal, Liam Blaney, John Beatty from the Governor's Veterans Office, William Higgins who put the presentation together and Representative Joseph McGonagle of Everett.

There being no objection, the Chair (Mr. Crighton) handed the gavel to Mr. O'Connor for the purpose of an introduction. Mr. O'Connor then introduced, in the rear of the Chamber, Bill Norton of Weymouth. Bill was recognized for organizing the "Kevin for Kids" toy drive, after his late partner Kevin McLean. In the past 12 years he has collected 21,529 toys for less fortunate children during the holiday season. Also recognized, was Army Staff Sergeant Andrew Fetrow, the new coordinator for Toys for Tots of Greater Boston. The Senate applauded his accomplishments, and he withdrew from the Chamber. He was accompanied by his brother Jim.

There being no objection, the Chair (Mr. Crighton) handed the gavel to Mr. Collins for the purpose of an introduction. Mr. Collins then introduced, Boston City Councilor Frank Baker. The Senate welcomed him with applause and he withdrew from the Chamber.

Report of a Committee.

Ms. Lovely, for the committee on Rules, reported that the following matter be placed in the Orders of the Day for the next session:

The House Bill merging the Shelburne Housing Authority with and into the Franklin County Regional Housing and Redevelopment Authority and restructuring the Franklin County Regional Housing and Redevelopment Authority members (House, No. 4772) (the committee on Rules having recommended that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 3140).

There being no objection, the rules were suspended, on motion of Mr. O'Connor, and the bill was read a second time and was amended, as recommended by the committee on Rules.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence with the amendment, its title having been changed by the committee on Bills in the Third Reading to read as follows: "An Act providing for the merger of the Shelburne Housing Authority with the Franklin County Regional Housing and Redevelopment and for the restructuring of the membership of the Franklin County Regional Housing and Redevelopment Authority".

Matters Taken Out of the Orders of the Day.

There being no objection, the following matters were taken out of the Orders of the Day and considered as follows:

The Senate Bill authorizing the town of Wareham to grant 5 additional licenses for the sale of all alcoholic beverages to be drunk on the premises (Senate, No. 2855),-- was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Pacheco presented an amendment substituting a new draft entitled "An Act authorizing the town of Wareham to grant 7 additional licenses for the sale of all alcoholic beverages to be drunk on the premises" (Senate, No. 3141).

The amendment was adopted.

The bill (Senate, No. 3141) was then passed to be engrossed.

Sent to the House for concurrence.

The House Bill amending the charter of the city of Newburyport (House, No. 3925),--was read a third time and passed to be engrossed, in concurrence.

The House Bill providing for tenant member appointment to the board of the Needham Housing Authority (House, No. 4964),-- was read a second time, ordered to a third reading, read a third time and passed to be engrossed, in concurrence.

PAPERS FROM THE HOUSE.

A petition (accompanied by bill, House, No. 5393) of Kay Khan that the State Retirement Board be authorized to grant certain creditable service to Robin Blatt, an employee of the Department of Public Health,-- was referred, in concurrence, under suspension of Joint Rule 12, to the committee on Public Service.

Order.

The following House Order (approved by the committees on Rules of the two branches, acting concurrently) was considered as follows:

Ordered, That, notwithstanding the provisions of Joint Rule 10, the committee on Telecommunications, Utilities and Energy be granted until Friday, December 16, 2022 within which time to make its final report on current House document numbered 5291.

The rules were suspended, on motion of Mr. O'Connor, and the order (House, No. 5357) was considered forthwith; and adopted, in concurrence.

The House Bill prohibiting license revocation for student loan default (House, No. 4339, amended),-- came from the House with the endorsement that the House had concurred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 3058, with a further amendment striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 5195.

The rules were suspended, on motion of Mr. O'Connor, and the further House amendment was considered forthwith and adopted, in concurrence.

The House Bill relative to the preparation of certain bilingual ballots in the city of Malden (House, No. 4793, amended),-- came from the House with the endorsement that the House had concurred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 3122, with further

amendments in section 2 by inserting after the word "state", in line 11, the first time that it appears, the words: "primary and"; in section 4, by inserting after the word "state", in line 21, the words: "primary and"; in section 5 by inserting after the words "ballots for", in line 34, the words: "federal or"; and by adding the following section:

"SECTION 6. This act shall take effect on January 1, 2023.".

The rules were suspended, on motion of Mr. O'Connor, and the further House amendment was considered forthwith and adopted, in concurrence.

Engrossed Bills.

The following engrossed bills (both of which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, were severally passed to be enacted and were signed by the Acting President (Mr. Crighton) and laid before the Governor for his approbation, to wit:

Designating the portion of United States highway route 20 in Massachusetts the Medal of Honor Highway (see House, No. 4436, amended); and

Exempting Jonathan Dillon from the maximum age requirement for original appointment as a police officer in the town of Dedham (see House, No. 4999, amended).

Kenny's memory will be cherished by his daughter Emily McLeod, the light of his life, his two sisters Maryann McLeod Crush and Carol Mcleod Brooks, Carol's husband Joseph Brooks, his nieces Ashley Crush and Brittany Crush his great nephew Liam Michael Crush in addition to his many cousins and friends.

Kenny's lifelong passion was music followed by art as a close second. As a young teenager, Kenny practiced playing the drums in the basement of his home at 137 P Street during the early 1960's. He and his friends would charge 25 cents for their concerts. Many neighbors and even a few teachers (nuns) from St. Brigid School came to listen to "Rock and Roll" which was the cusp of a new musical frontier during the boomer generation. Kenny was known for his kind, helpful spirit. He was truly a gentle giant.
