Monday, April 24, 2023.

Met at seventeen minutes past eleven o'clock A.M. (Mr. Collins in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

Report of a Committee.

Adjournment in Memory Katherine “Kay” Murphy.

The Senator from Essex and Middlesex, Mr. Tarr moved that when the Senate adjourns it does so in memory of Katherine “Kay” Murphy of Rockport, who passed away on March 29 at the age of 94. Katherine was a pillar of the Rockport community for more than 60 years serving on the town Select Board, the School Committee, and the Recreation Committee, and for many years provided a special brand of encouragement to generations of youngsters as a permanent substitute teacher in the Rockport public schools.

Kay grew up in Ipswich and graduated from Ipswich High School in 1946. She played on the basketball team and performed in student stage productions. She graduated from Salem State University in 1951. In 1950, she married Jeremiah V. Murphy. After Jerry landed his dream job with the Boston Globe, the couple moved to Rockport.

Kay and Jeremiah would have seven kids, at one point there was a Murphy child in seven of the 12 grades in Rockport. Jeremiah enjoyed great success as a columnist, and Katherine thrived in Rockport, then a community of less than 5,000. She was a great supporter of her husband's work; he periodically praised her in print as his "Katherine Mary."

With Kay's encouragement, her son Sean followed in his father's footsteps to become a longtime Boston Globe journalist; her son Paul followed in her footsteps to become a longtime member of the Rockport Select Board; both her daughters Betsy and Kathy became public school teachers; and her oldest, Jerry, is still playing tennis past age 70.

Kay was predeceased by two of her sons, Timothy in 2022, and Kean in 1993, and her husband Jeremiah V. Murphy. She is survived by Jeremiah III (Mary) of Swampscott, Elizabeth ("Betsy") Blodgett (Timothy) of Gloucester, Sean (Deirdre) of Quincy, Kathleen "Kathy" Burley of Gloucester, and Paul (Marybeth) of Rockport; 12 grandchildren and two great-grandchildren.
