## JOURNAL OF THE SENATE

Monday, May 8, 2023.

Met at ten minutes past eleven o'clock A.M. (Ms. Jehlen in the Chair).

The Chair (Ms. Jehlen), members, guests and staff then recited the pledge of allegiance to the flag.

### Communication.

Communication from the Executive Office of Health and Human Services (pursuant to Section 13L of Chapter 118E of the General Laws) submitting its 340B high-cost drugs impact report (received May 5, 2023),-- was placed on file.
