Thursday, July 6, 2023.

Met at twenty-four minutes past eleven o'clock A.M. (Mr. Rodrigues in the Chair).

The Chair (Mr. Rodrigues), members, guests and staff then recited the pledge of allegiance to the flag.

Adjournment in Memory of Mary Camille Clougher.

The Senator from Norfolk and Plymouth, Mr. Keenan, moved that when the Senate adjourns today it do so in memory of Mary Camille Clougher.

Mary Camille Clougher of Holbrook passed away peacefully at the age of 62 on March 8, 2023, surrounded by her loved ones, after a courageous battle with Multiple Myeloma. Mary is survived by her devoted husband of 37 years, William Clougher, as well as her beautiful children, Paul Clougher, Phillip Clougher, and Marisa Politano and her husband Zachary.

Mary was born in Dorchester and grew up in South Boston and Quincy. She was the daughter of the late Camille and Paul Satkewich and a loving sister to her brother, Charles Satkewich and his wife Marie; her late sister-in-law Elise Lavidor Satkewich; her sister, the late Anna Hogan; her brother-in-law, Frank Hogan and his wife Barbara; and her beloved twin brother, John Satkewich and his wife Darlene. Mary was a beloved daughter-in-law to the late John Clougher and his wife Mary McLaughlin Clougher, and the loving aunt and Godmother to her many nieces and nephews.

Mary graduated from North Quincy High School in 1978 and the University of Massachusetts Boston in 1982, majoring in Political Science and History. She taught in the Holbrook Public Schools since 2002 at the John. F. Kennedy School, the South School and Holbrook Middle-High School.

As the Advisor to the Civics Club which she founded in 2008, Mary spearheaded Project Citizen and in 2018 received an "Unsung Heroine Award of Massachusetts" after a bill she and her students filed and advocated for became law, commemorating Peace Day in Massachusetts every September 21st.

In 2020 Mary received the "Adult Advisor Award" and "Outstanding Chapter Award" from the Massachusetts 84 Movement, a statewide movement of youth fighting tobacco use. She and her students worked hard to pass comprehensive tobacco ordinances in Holbrook and nearby towns, and then spearheaded legislation at the state level. During the legislative process, Mary and her students frequently came to the State House to testify at committee hearings, meet legislators, hold press conferences, and then for the bill signing ceremony with Governor Baker and state public health officials in 2019. Four other states have since passed similar laws.

Mary also worked with The Martin Richard Foundation to establish the Bulldogs Build Bridges and Bulldogs Don't Bully initiatives. She worked with various foundations and charities such as the Peace One Day Foundation, Students Against Destructive Decisions, Sandy Hook Promise, Pennies for Patients, and Hasbro Toy Drive. She codirected each musical, concert and theater camp production at Holbrook High School since

2004 and served as an Advisor for Soldiers Club and Student Council. Mary organized Voter Registration Drives, Student Government Day, Memorial Day Parades, Flag Day Ceremonies, welcome home parties for servicemembers, and Christmas Tree Lightings. In 2015, she marched on Washington with Holbrook Cares to fight to end the stigma associated with substance use. As a CCD teacher at St. Joseph's Parish, she was a "Light of the World Award" recipient.

In Mary's life there were many constants, first and foremost love. Her love for family was incredibly deep and everlasting. She loved her many friends. And she loved the students to whom she gave such devotion, teaching and encouraging them to be kind and caring, to be active and engaged, to have peace in their hearts, and to appreciate the gift of each day. She could do all this because that is how she lived.

Often it is said when a person dies the world suffers a loss. With Mary's passing this is true, but the greater truth is that the world is a better place and will keep getting better because Mary lived.

Accordingly, as a mark of respect to the memory of Mary Camille Clougher, at eight minutes before twelve o'clock noon, on motion of Mr. Tarr, the Senate adjourned to meet again on Monday next at eleven o'clock A.M.
