Monday, July 10, 2023.

Met at twenty-three minutes past eleven o'clock A.M. (Mr. Timilty in the Chair).

The Chair (Mr. Timilty), members, guests and staff then recited the pledge of allegiance to the flag.

PAPERS FROM THE HOUSE.

The House Bill establishing a sick leave bank for Michael Grant, an employee of the department of correction (House, No. 3821, amended),-- came from the House with the endorsement that the House had NON-concurred in the Senate amendment by adding the following sentence:- "The employee must exhaust all accrued leave time before accessing time from the sick leave bank."

Adjournment in Memory of Former Braintree Deputy Fire Chief Alton Parker Nadeau.

The Senator from Norfolk and Plymouth, Mr. Keenan and the Senator from Norfolk, Plymouth and Bristol, Mr. Timilty moved that when the Senate adjourns today it does so in memory of Former Braintree Deputy Fire Chief Alton Parker Nadeau.

Former Braintree Deputy Fire Chief Alton Parker Nadeau, a veteran of the Korean War, passed away on June 14. Deputy Chief Nadeau, known as Parker, served on the fire department for more than three decades.

Born and raised in the Fields Corner section of Dorchester, Deputy Chief Nadeau joined the US Air Force. Here, he served for four years during the Korean War. While in

the service, he held the rank of staff sergeant, serving as chief clerk.

Deputy Chief Nadeau married Virginia Hennessey and settled in Braintree where they raised their two children, Larry Nadeau, and Robin Nadeau. Then, in 1958, he joined the Braintree Fire Department, retiring in 1994 as Deputy Chief.

Having remarried in 1988 to Rhea Polson, they were together until her death in 2005. Deputy Chief Nadeau was predeceased by his parents, Alton Nadeau and Marion DeLori, and his stepson, Kevin.

He is survived by his children, Larry Nadeau, Robin Nadeau, and Matt Polson and his wife Ashley; and his stepsons, David Polson and his wife, LeAnn, Eric Polson and his wife, Laurie, and Steven Polson. Parker also leaves behind many grandchildren and greatgrandchildren all of whom he was very proud.

Deputy Chief Nadeau was always a warm and loving person who treated everyone he came in contact with like family. He will be sorely missed by all who had the pleasure to know him.
