## JOURNAL OF THE SENATE

Monday, July 24, 2023.

Met at twelve minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

## Adjournment in Memory of Dora Robinson.

The Senator from Hampden, Hampshire and Worcester, Mr. Oliveira, and the Senator from Hampden, Mr. Gomez, moved that when the Senate adjourns today, it do so in memory of Dora Robinson, a longtime Springfield community leader and mentor, former CEO of the United Way of Pioneer Valley, and executive director of Martin Luther King Jr. Family Services.

Dora, born on August 7, 1951, in Elmira, New York, was blessed with the love and support of her parents, Laura Belle Watkins and Arthur Givens. The void created by her passing is felt deeply by her devoted husband, Frank P. Robinson; her beloved mother, Laura Watkins; her daughter Kimberly Robinson Williams; her sisters, Citasha Givens, and Sandi Givens-Brown, as well as her grandchildren and godchildren, who held a special place in her heart.

After graduating with a bachelor's degree from Cornell University in 1976, Dora's passion for making a difference led her to pursue a Master's Degree in Social Work from the University of Connecticut. Her dedication to service and unwavering commitment propelled her to achieve remarkable milestones throughout her life.

Dora shattered barriers as the first female president of the United Way of Pioneer Valley and faithfully served as the executive director of Martin Luther King Jr. Family Services for an impressive 18 years. Her invaluable contributions extended beyond these roles. She also served as the corporate director of child and family services at the Center for Human Development, Vice President of Education at the Urban League of Springfield,
