Sara Covello Massa passed away peacefully on Friday, November 3rd, 2023 after a brief illness at the age of 102.

Born in the North End of Boston as the daughter of Sicilian immigrant parents in 1921, Sara spent most of her early life in the greater Boston area before moving to Tewksbury with her late husband, Joseph, and their three children, Joseph Jr, Joanne, and Lorraine.

Sara was an exceptional wife, mother, aunt, grandmother, and great-grandmother. She enjoyed playing bingo at the Tewksbury Senior Center, reading, traveling, and she loved to cook.

Survived by her 15 great-grandchildren plus numerous nieces and nephews, Sara will be remembered as the beloved matriarch of her family. Our thoughts go out to all of Sara's family, as well as the broader Tewksbury and Wilmington communities impacted by her loss.
