JOURNAL OF THE SENATE

Monday, June 24, 2024.

Met at seven minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Distinguished Guests.

There being no objection, the Chair (Mr. Brownsberger) handed the gavel to Mr. O'Connor for the purpose of introducing several guests.

Mr. O'Connor introduced, in the rear of the Chamber, the Notre Dame Academy girls soccer team. The team was recognized for winning the 2023 MIAA Division 2 state championship title, in a 1-0 win against Mansfield High School. The student-athletes were applauded for their hard work and dedication and for completing the season with a 9-3-1 record. The team was accompanied by Head Coach Kelly Turner and Representative Meschino of Hull.

PAPERS FROM THE HOUSE.

A Bill designating a portion of state highway Route 41 in the town of West Stockbridge as the Gene Dellea highway (House, No. 4618, amended-- on petition),-- was read.

Report of a Committee.

By Mr. Rodrigues, for the committee on Ways and Means, that the House Bill relative to the Affordable Homes Act (House, No. 4726),-- ought to pass with an amendment striking out all after the enacting clause and inserting in place thereof the text of Seante document numbered 2834 (General Obligation Bonds: \$5,196,000,000.00).

Procedural order.

Order Adopted.

Mr. Rodrigues presented the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill relative to the Affordable Homes Act (House, No. 4726) (the committee on Ways and Means having recommended that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2834) shall be placed in the Orders of the Day for a second reading on Thursday, June 27th, 2024.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 5:00 P.M, on Tuesday, June 25th, 2024. All such amendments shall be second reading-amendments to the Senate Ways and Means new text (Senate, No. 2834), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

The rules were suspended, on motion of Mr. Rodrigues, and the order was considered forthwith and adopted.

The bill will be considered on Thursday, June 27th, 2024, for a second reading with the amendment pending.
