Monday, July 15, 2024.

Met at five minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed, by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

While we may disagree on many things, we are deeply committed to this country's ideals of settling those disagreements through public participation, debate, and respect for our colleagues regardless of their affiliation. We grieve for the families affected by Saturday's tragedy and condemn those who would seek to use violence to further their political goals.

Mr. Rodrigues presented the following order, to wit:

Ordered, That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill enhancing the market review process (House, No. 4653) (the committee on Ways and Means having recommended that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2871) shall be placed in the Orders of the Day for a second reading on Thursday, July 18, 2024.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 3:00 P.M, on Tuesday, July 16, 2024. All such amendments shall be second reading-amendments to the Senate Ways and Means new text (Senate, No. 2871), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.

The rules were suspended on motion of Mr. O'Connor, and the order was considered forthwith and adopted.

The bill will be considered on Thursday, July 18th, 2024, for a second reading with the amendment pending.
